ADMINISTRATIVE PROCEEDINGS

LOUIS MORGAN CITED

The Commission instituted public administrative proceedings under Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 against Louis Morgan of Northbrook, Illinois. Morgan is president of SFC Equities, Inc., a registered broker-dealer located in Northbrook, Illinois.

In anticipation of these proceedings, Morgan submitted an Offer of Settlement which the Commission accepted. Without admitting or denying the allegations of the Commission's Order Instituting Public Administrative Proceedings and Imposing Remedial Sanctions, Morgan consented to findings that the U.S. District Court for the Northern District of Illinois permanently enjoined him from violations of the registration and antifraud provisions of the securities laws, and that he wilfully violated and wilfully aided and abetted violations of those provisions.

In accepting Morgan's Offer of Settlement, the Commission suspended him from association with any broker, dealer, investment adviser, investment company or affiliate of any of the foregoing for 12 months. (Rel. 34-20247)

CIVIL PROCEEDINGS

COMPLAINT NAMES C. & R. PASTOR SECURITIES, INC., OTHERS

The New York Regional Office filed a complaint on September 27 in the U.S. District Court for the Southern District of New York charging C. & R. Pastor Securities, Inc. (Registrant), a New York City brokerage firm; C. & R. Pastor Securities Ltd., SA (C. & R. Pastor), a Spanish corporation with offices in Madrid; Rafael B. Pastor (Pastor) and James Anthony Lockart, the president and vice-president of Registrant, with violations of the antifraud provisions of the securities laws.

The complaint charges that: from mid-August 1983 to date, the defendants entered orders to sell securities with at least six broker-dealers located in New York City without informing the broker-dealers of the ownership of the securities sold; the securities sold were not in the possession of any of the defendants and they would not be available for delivery at the time of settlement; at the time that the defendants placed the sell orders, they intended to deliver-in the securities only if a favorable movement in the price of the securities occurred between trade date and settlement date; the volume of the defendants sale transactions was approximately \$200 million; and the broker-dealers sustained a loss of at least \$21 million.

The complaint seeks a temporary restraining order, preliminary and permanent injunctive relief, an order requiring the defendants to make available Registrant's books and records to the Commission, and an order that defendants not dissipate or transfer their assets. (SEC v. C. & R. Pastor Securities, Inc., et al., 83 Civil 7053 (RLE), S.D.N.Y.). (LR-10159)

TRIUNION, OTHERS ENJOINED

The Washington Regional Office announced that on September 26 Judge John F. Gerry, U.S. District Court for the District of New Jersey, entered Final Judgments and Orders permanently enjoining Triunion, Francis Coughlin, Jr., William A. Pascoe, William P. Leonard and Henry F. Pitchford from violations of the registration requirements and antifraud provisions of the securities laws. The defendants consented to the injunctions without admitting or denying the allegations of the complaint. (SEC v. Triunion, et al., D.N.J., Civil Action No. 83-3574). (LR-10160)
