# CIVIL PROCEEDINGS

ORDERS TO SHOW CAUSE ENTERED AGAINST STEPHEN SMITH

The Commission announced that on September 20 Judge Charles S. Haight, of the U.S. District Court for the Southern District of New York, entered Orders to Show Cause why Stephen Smith, of New York, New York, should not be held in civil and criminal contempt of a Final Judgment of Permanent Injunction. The Final Judgment was previously entered with Smith's consent by Judge Haight on March 12, 1981. The Judgment enjoined Smith from violating the beneficial ownership reporting requirements of the Securities Exchange Act of 1934. In its Application for Orders to Show Cause, the Commission alleged that Smith did not file certain reports every six months for five years stating (a) his ownership of, (b) his membership in any group for the purpose of acquiring, holding or disposing of and (3) any contracts, arrangements or understandings that Smith may have respecting 5,000 or more shares of any equity securities registered with the Commission under Section 12 of the Exchange Act as required by the Final Judgment. #### ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved, on an accelerated basis, a proposed rule change filed by the Chicago Board Options Exchange, Incorporated (SR-CBOE-83-36) to provide that options on CBOE's Standard and Poor's 100 Index Option will expire in consecutive months.
