CIVIL PROCEEDINGS

GOLDFIELD DEEP MINES COMPANY OF NEVADA, OTHERS PERMANENTLY ENJOINED

The Los Angeles Regional Office announced that on September 28, after a trial on the merits, Judge Francis C. Whelan, U.S. District Court for the Central District of California, entered a Final Judgment of Permanent Injunction with Findings of Fact and Conclusions of Law against Goldfield Deep Mines Company of Nevada, a company with securities registered with the Commission under Section 12(g) of the Securities Exchange Act of 1934, AAA Financial Corporation, City Continental Financial A.G., John C. Rebenstorf, III, C. Orin Swain and Morton Johnson. The Judgment permanently enjoins the defendants from further violations of the antifraud, reporting and books and records provisions of the securities laws.

The Court found that the defendants, from at least 1981 through the present, knowingly and intentionally defrauded investors in Goldfield's common stock and investment contracts in the form of ore interests by misrepresenting and omitting to disclose material information about Goldfield. The Court further found that Goldfield's June 22, 1982 Form 10 Registration Statement, and December 13, 1982 Amendment thereto contained financial statements which were grossly inaccurate and that its major asset reflected therein, approximately \$4.5 million of notes receivable from City Continental, were from a non-existent entity and non-recoverable. Further, Goldfield misrepresented or failed to disclose material information about itself and its management. Finally, the Court found that Goldfield failed to make and keep complete and accurate books and records, failed to maintain a system of internal accounting controls and failed to maintain accountability for assets.

In a related matter, the Court found that Rebenstorf had wrongfully removed approximately \$140,000 of Goldfield's assets from Goldfield and AAA Financial bank accounts the day preceding the entry of a Temporary Restraining Order against the defendants on April 1, 1983 and attempted to convert such assets to his personal use. The Court found that Rebenstorf's attempt to collect on purported 1974 Goldfield promissory notes payable to himself, which were in fact executed in 1983, was a ruse to milk cash from the Goldfield and AAA Financial bank accounts. CRIMINAL PROCEEDINGS

PAUL J. KIEPURA PLEADS GUILTY

On October 11, Paul J. Kiepura pled guilty to a two-count criminal information filed in the U.S. District Court for the Northern District of Illinois. The criminal information charged Kiepura, a former representative with Blunt, Ellis & Loewi, Inc. in Schaumberg, Illinois, with unauthorized transfers of customers funds and the misappropriation of customer cash deposits of approximately \$98,500.
