CIVIL PROCEEDINGS

U.S. SECURITIES AND EXCHANCE COMMISSION

ORTHOMOLECULAR NUTRITION INSTITUTE, INC. ENJOINED

The Commission announced that on October 5 the U.S. District Court for the District of Columbia entered a Final Judgment of Permanent Injunction against Orthomolecular Nutrition Institute, Inc. (Ortho), of New York, New York, restraining and enjoining Ortho from failing to file and file timely periodic reports, and ordering it to comply with certain undertakings. The complaint, filed on June 29, alleged that Ortho, as part of a continuing course of violative conduct extending over several years, failed to file and file timely certain annual and quarterly reports required to have been filed. Ortho, consenting to the entry of the Court's judgment, admitted that it had filed reports in an untimely manner on seven separate occasions and failed to file Notifications of Late Filing on four separate occasions. JACK D. SOLOMON CONSENTS TO INJUNCTION

The San Francisco Branch Office announced that on October 11 Judge Harry E. Claiborne, U.S. District Court for the District of Nevada, issued an order permanently enjoining Jack David Solomon of Las Vegas from violations of the registration, antifraud, stock ownership reporting and proxy solicitation provisions of the securities laws. The order was issued with Solomon's consent. He neither admitted nor denied the violations alleged in the complaint. The litigation is continuing with respect to Solomon's co-defendant, Norman LaVerne Vance. (SEC v. Jack David Solomon and Norman LaVerne Vance, Civ. LV 83-494 HEC, D. Nev.). (LR-10174)
