COMMENTS REQUESTED ON RULE 29

The Commission requests comments on Rule 29 under the Rules of Practice, 17 CFR 201.29. The rule relates to applications by barred individuals for consent to associate with a registered broker, dealer, municipal securities dealer, investment adviser or investment company. The rule will set forth the procedures to be followed by certain individuals who are barred by Commission order, and thereafter submit an application to the Commission for consent to associate or to change the terms and conditions of association, with a registered broker, dealer, municipal securities dealer, investment adviser, or investment company.

Comments should be submitted in triplicate to the Office of the Secretary, Securities and Exchange Commission, 450 Fifth Street, N.W., Washington, DC 20549, no later than 30 days after publication in the Federal Register. (Rel. 34-20393)

RULE ADOPTED PROHIBITING BROKER-DEALERS FROM USING CERTAIN PREDISPUTE ARBITRATION CLAUSES

> The Commission adopted a rule that prohibits broker-dealers from using predispute arbitration clauses in customer agreements that purport to bind public customers to the arbitration of claims arising under the securities laws. The rule also requires broker-dealers to disclose to existing public customers that they are not precluded by such clauses from judicial recourse with respect to those claims. The purpose of this rule is to ensure that public customers are not misled concerning such recourse. (Rel. 34-20397)

PHASE-IN PROGRAM FOR OPTIONS ON NARROW-BASED STOCK INDICES

> To provide for the orderly introduction of options on narrow-based stock indices, the Commission issued a statement of general policy under which it states that it is limiting each self-regulatory organization seeking to trade narrow-based index options to a maximum of two such contracts until February 1, 1984. CIVIL PROCEEDINGS

COMPLAINT NAMES ELECTROMEDICS, INC., OTHERS

The Commission today filed a civil action for injunctive and other equitable relief in the U.S. District Court for the District of Columbia against Electromedics, Inc., Terry L. Clark, and F. James Lynch, Jr., all located in or around Denver, Colorado, alleging violations of the antifraud, reporting and accounting provisions of the securities laws. Without admitting or denying the allegations in the complaint, Electromedics and Clark consented to the entry of Final Judgments of Permanent Injunction and other Equitable Relief, and Lynch consented to the entry of a Final Order. The complaint alleges that: during its 1981 fiscal year and continuing in its 1982 fiscal year, Electromedics misrepresented to its shareholders and the public its financial condition and net income; beginning in January 1981 and continuing until June 1982, Clark caused false and unsupported journal entries to be made to Electromedics' general ledger causing overstatements of the Company's inventory and understatements of its costs of sales; Lynch failed to heed warnings from certain Company employees that Electromedics' inventory was overstated on its books and that Clark was making adjusting journal entries that were unsupported; and in 1983, subsequent to an interal investigation, Electromedics restated its affected financial statements. SEI FINANCIAL SERVICES COMPANY

A notice has been issued giving interested persons until December 12 to request a hearing on an application of Institutional Telephone Trust, First Exchange Series and Subsequent Series, registered under the Investment Company Act of 1940 as a unit investment trust, and SEI Financial Services Company, its sponsor, for an order exempting them from the provisions of Sections 7(c), 14(a) and 19(b) of the Act and Rule 19b-1. HOLDING COMPANY ACT RELEASES

AMERICAN ELECTRIC POWER COMPANY

A notice has been issued giving interested persons until December 13 to request a hearing on a proposal by the American Electric Power Company, Inc. (AEP), a registered holding company, to issue short-term notes during 1984 to banks and to a commercial paper dealer, in an aggregate amount outstanding at any one time of \$165 million. AEP also proposes to make capital contributions to subsidiaries in an amount of \$182 million. Columbus and Southern Ohio Electric, Indiana & Michigan Electric Company, Kentucky Power Company, Kingsport Power Company, and Michigan Power Company, subsidiaries of AEP, also propose to issue short-term notes in a combined amount of \$354.5 million. An exception from competitive bidding has been requested for the sale of commercial paper notes. (Rel. 35-23134 - Nov. 18)

EFFECTIVENESS OF PROPOSED RULE CHANGE

A rule change filed by the National Securities Clearing Corporation (SR-NSCC-83-12) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The proposed rule change enables NSCC to act as a collection agent for self-regulatory organizations and security industry groups. The rule change also makes technical adjustments to NSCC's Fee Structure. (Rel. 34-20394)
