INVESTMENT COMPANY ACT RELEASES

VENTURE MUNI (+) PLUS, INC.

A notice has been issued giving interested persons until March 1 to request a hearing on an application by Venture Muni (+) Plus, Inc. for an order exempting it from the provisions of Sections 2(a)(32), 2(a)(35), 22(c) and 22(d) of the Investment Company Act and Rules 22c-1 and 22d-1 to permit it to assess (and waive in certain cases) a contingent deferred sales charge on redemptions of its shares. The application also permits certain exchange transactions. (Rel. IC-14353 - Feb. 4)

FIRST INVESTORS NEW YORK TAX FREE FUND, INC.

A notice has been issued giving interested persons until March 4 to request a hearing on an application by First Investors New York Tax Free Fund, Inc. (Applicant) for an order exempting it from Section 22(d) of the Investment Company Act to permit unitholders of New York Insured Municipals Income Trust, Series I and past and subsequent series, to reinvest distributions of interest income, capital gains or principal in shares of Applicant at a reduced sales load. HOLDING COMPANY ACT RELEASES

HAWAIIAN ELECTRIC INDUSTRIES, INC.

An order has been issued approving a proposal by Hawaiian Electric Industries, Inc. that it be permitted to create one or more subsidiaries for the purpose of owning and operating alternate energy and/or cogeneration facilities. (Rel. 35-23592 - Feb. 5)

JERSEY CENTRAL POWER & LIGHT COMPANY

An order has been issued authorizing a proposal by Jersey Central Power & Light Company (JCP&L), subsidiary of General Public Utilities Corporation, and its newly formed subsidiary, Energy Initiatives Incorporated (EII). EII proposes to issue to JCP&L and JCP&L will purchase all the common stock of EII consisting of 10,000 shares of common stock (no par value) for an aggregate of \$100,000. Thereafter, JCP&L will make open account advances to EII of up to \$1 million per year for five years. EII may also effect secured and/or unsecured borrowings from suppliers of facilities which EII owns and/or from institutional lenders for an aggregate principal amount of up to \$2 million from time to time until December 31, 1986. Such financing will enable EII to invest in qualifying cogeneration and small power production projects and to otherwise carry on business. (Rel. 35-23593 - Feb. 5)

SELF-REGULATORY ORGANIZATIONS

NOTICE OF PROPOSED RULE CHANGE

The New York Stock Exchange, Inc. filed a proposed rule change under Rule 19b-4 (SR-NYSE-85-1) to amend its rules relating to percentage orders, Rules 13 and 123A.30. The amendment will permit "conversions" of percentage orders into regular limit orders on "destabilizing" ticks where the transaction is for at least 10,000 shares, and the price is not more than 1/4 point away from the last sale; and when conversion would "better the market" by narrowing the quotation spread or adding size to the existing quotation. Publication of the proposal is expected to be made in the Federal Register during the week of February 11. (Rel. 34-21704)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved, on an accelerated basis, a proposed rule change filed by the Philadelphia Stock Exchange, Inc. (SR-Phix-85-1) which extends Phix's Designated Underlying Index Transaction pilot program for one year. (Rel. 34-21709)

IMMEDIATE EFFECTIVNESS OF PROPOSED RULE CHANGES

Proposed rule changes became effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934 by: The Pacific Stock Exchange, Inc. (SR-PSE-84-13) to amend Commentary .01 of PSE Rule VI, Section 62 by clarifying a floor broker's due diligence requirement to ascertain the best price available for an order, and by incorporating language from PSE Options Floor Procedure Advice A-8 into Commentary .01 and withdrawing Advice A-8. (Rel. 34-21713); The Midwest Clearing Corporation (SR-MCC-85-1) which increases certain service and trading recording charges and decreases certain member-to-member stock loan charges. (Rel. 34-21719); and The Midwest Securities Trust Company (SR-MSTC-85-1) which increases certain account maintenance, settlement service, and depository service charges. The proposal also revises MSTC's fee structure for legal deposits in New York and Chicago. (Rel. 34-21720)

THE WESTERN UNION TELEGRAPH COMPANY

A notice has been issued giving interested persons until March 8 to request a hearing on an application by the Western Union Telegraph Company for a determination by the Commission that J. Henry Schroder Bank and Trust Company should not be deemed to have a conflicting interest within the meaning of Section 310(b) of the Trust Indenture Act which would disqualify it from acting as successor trustee under certain indentures, as a result of acting under ten qualified indentures.
