

INVESTMENT COMPANY ACT RELEASES

SPR FUND, INC. TRUST FOR SHORT-TERM INSTRUMENTS

> Orders have been issued declaring that SPR Fund, Inc. and Trust for Short-Term Instruments have ceased to be investment companies. (Rel. IC-14368; IC-14369 - Feb. 12)

LEGG MASON TAX-EXEMPT TRUST, INC.

A notice has been issued giving interested persons until March 11 to request a hearing on an application by Legg Mason Tax-Exempt Trust, Inc., for an order exempting it from from the provisions of Sections 12(d)(3) and 2(a)(41) of the Investment Company Act and Rules 2a-4 and 22c-1. This will permit Legg Mason to acquire rights to sell its portfolio securities to brokers or dealers and to value such rights in the manner described in the application. (Rel. IC-14370 - Feb. 12)

PAINE, WEBBER MUNICIPAL BOND FUND FIRST AND SUBSEQUENT SERIES

> An order has been issued exempting certain principal transactions between Paine, Webber Municipal Bond Fund First Series and Subsequent Series, et al. and PaineWebber Incorporated from the provisions of Section 17(a) of the Investment Company Act. (Rel. IC-14371 - Feb. 12)

HOLDING COMPANY ACT RELEASES

NATIONAL FUEL GAS COMPANY

An order has been issued authorizing National Fuel Gas Company (National), a registered holding company, and its subsidiaries, National Fuel Gas Supply Corporation, Penn-York Energy Corporation, National Fuel Gas Distribution Corporation, Seneca Resources Corporation and Empire Exploration, Inc., to enter into intra-system borrowing arrangements through a system money pool for the year 1985. Distribution, Supply, Seneca, Penn-York and Empire propose to borrow \$150, \$125, \$109.625, \$20 and \$20 million, respectively. National also seeks authorization to issue and sell, through December 31, 1985, up to \$80 million aggregate principal amount outstanding at any one time of its commercial paper and up to \$262 million of notes to banks under external short-term lines of credit. The commercial paper and short-term bank borrowings would not exceed an aggregate principal amount outstanding at any one time of \$375 million. (Rel. 35-23598 - Feb. 12)

MIDDLE SOUTH UTILITIES, INC.

An order has been issued regarding Middle South Utilities, Inc., a registered holding company, and its subsidiary, Arkansas Power & Light Company (AP&L), authorizing Middle South to acquire and AP&L to issue and sell its common stock, through December 31, 1985, for a cash consideration of \$60 million. (Rel. 35-23599 - Feb. 12)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved proposed rule changes filed by: The Chicago Board Options Exchange, Inc. (SR-CBOE-84-33) to enable CBOE to amend its Order Support System (OSS) to eliminate the contract size limit on orders otherwise eligible for OSS. (Rel. 34-21741); The National Association of Securities Dealers, Inc. (SR-NASD-84-28) that permits the NASD's Small Order Execution System to operate until July 1, 1986. (Rel. 34-21742); (SR-NASD-84-26) that describes the NASD's Small Order Execution System. (Rel. 34-21743); The Philadelphia Stock Exchange, Inc. (SR-Phix-84-29) to adopt Rule 1067, which provides that the highest bid and the lowest offer shall have precedence in all options trading. (Rel. 34-21744); The Philadelphia Depository Trust Company (SR-Philadep-84-5) that establishes Philadep as a "qualified registered securities depository" for purposes of Securities Exchange Act Rule 17Ad-14. The proposal includes procedures for automated book-entry processing of securities movements during tender and exchange offers. (Rel. 34-21747); The Midwest Stock Exchange, Inc. (SR-MSE-84-12) modifying an Article XXX, Rule 1.01 of MSE's rules applicable to the splitup or merger of an MSE specialist unit and the possible assignment or reassignment of the unit's stocks in event of such split-up or merger. (Rel. 34-21749); and The American Stock Exchange, Inc. (SR-Amex-82-27) to allow options specialist firms to make recommendations for the purchase or sale of the securities underlying specialty options. (Rel. 34-21750)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission approved, on an accelerated basis, proposed rule changes filed by: <u>The New York Stock Exchange, Inc</u>. (SR-NYSE-84-41) that permits NYSE to begin opening rotations for index options promptly following the official time trading opens in the primary market for the majority of the underlying stocks that comprise the index. (Rel. 34-21745); and <u>The Chicago Board Options Exchange, Inc</u>. (SR-CBOE-85-2) to permit sales personnel of member organizations to become qualified regarding options on government securities after passing the CBOE's Interest Rate Options Qualification Examination. (Rel. 34-21748)

NOTICE OF PROPOSED RULE CHANGE

The Municipal Securities Rulemaking Board filed a proposed rule change under Rule 19b-4. This rule change (SR-MSRB-85-4) is intended to indicate clearly that good delivery of a municipal security for which a notice of call applicable to the entire issue of securities has been published on or prior to the trade date has not been effected unless the security was identified as called at the time of trade. Publication of the proposal is expected to be made in the <u>Federal Register</u> during the week of February 11. (Rel. 34-21746)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A rule change filed by the Depository Trust Company has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The proposed rule change (SR-DTC-85-1) establishes certain fees for accepting deposits and maintaining long positions in certain types of municipal bearer securities that recently became depository eligible. (Rel. 34-21755)
