ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved, on an accelerated basis, a proposed rule change filed by The Boston Stock Exchange, Inc. (SR-BSE-85-1) to amend several of its rules relating to arbitration. Among other changes, the proposed amendments would affect the six-year time limitation on arbitrations, the pleadings of responding parties, the procedures for amendment of pleadings, fee schedules, and the jurisdictional limit for small claim proceedings.
