## RULES AND RELATED MATTERS

AMENDMENTS TO RULE 22c-1 AND A NEW RULE 22e-2 ADOPTED

The Commission adopted amendments to Rule 22c-1 and a new Rule 22e-2 under the Investment Company Act of 1940. Rule 22c-1, as amended, requires investment companies to calculate the net asset value of their redeemable securities only on regular United States business days exclusive of customary national, regional and local holidays as disclosed to shareholders. Rule 22e-2 makes clear that an investment company which prices redemption requests in accordance with Rule 22c-1 will not have violated Section 22(e). (Rel. IC-14559)

## **ADMINISTRATIVE PROCEEDINGS**

PROCEEDINGS INSTITUTED AGAINST JACOB EDERMAN

Public administrative proceedings have been instituted under the Securities Exchange Act of 1934 against Jacob Ederman, formerly employed by and associated with Philips, Appel and Walden, Inc., a registered broker-dealer, as a registered representative.

The Order for Proceedings alleges, among other things, that Ederman's conviction upon his plea of guilty, within the preceding ten years, to one count of an Information in the U.S. District Court for the Southern District of New York, which involves perjury, subjects him to remedial sanctions under Section 15(b)(6) of the Exchange Act.

A hearing will be scheduled to take evidence on the allegations against Ederman. The purpose of the hearing is to determine whether or not the allegations against Ederman are true, and if so, what, if any, remedial action is necessary in the public interest. (Rel. 34-22108)

### CIVIL PROCEEDINGS

ACTION FILED AGAINST LA-MAN CORPORATION

The Commission announced on June 6 the filing and settlement of a civil injunctive action in the U.S. District Court for the District of Columbia against La-Man Corporation, a Hamilton, Indiana company. The complaint alleged that La-Man engaged in the sale of unregistered securities in violation of the registration provisions of the Securities Act of 1933. Additionally, the complaint alleged that La-Man filed a false and misleading registration statement with the Commission in that it failed to disclose, among other things, material relationships and transactions between the company and the company's financial consultants. La-Man, without admitting or denying the complaint's allegations, consented to an order permanently enjoining it from violating the antifraud and registration provisions of the Securities Act and the antifraud provisions of the Securities Exchange Act of 1934. An order has been issued exempting American Pension Investors Trust (Trust) and American Pension Distributors, Inc. from the provisions of Section 2(a)(32), 2(a)(35), 22(c) and 22(d) of the Investment Company Act and Rule 22c-1 to permit assessment (and waiver) of a contingent deferred sales load on certain redemptions of Trust shares. PARTIAL APPROVAL OF PROPOSED RULE CHANGE ON AN ACCELERATED BASIS

(SR-CBOE-85-22) which would amend its Order Support System to allow members to route electronically to its limit order book certain public customer limit orders in OTC stock options. (Rel. 34-22105)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The Chicago Board Options Exchange, Inc. filed a proposed rule change which became effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934 (SR-CBOE-85-18) not to charge book, transaction or trade match fees in classes of options on over-the-counter (OTC) stocks for the first 90 days after options on OTC stocks are opened for trading.
