ADMINISTRATIVE PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS INSTITUTED AS TO MAGNA CORPORATION

The Commission issued an Order Instituting Proceedings, under Section 15(c)(4) of the Securities Exchange Act of 1934, and Findings and Order of the Commission respecting Magna Corporation. The Commission ordered Magna to fully comply with periodic reporting, recordkeeping-internal controls and proxy soliciting provisions of the Exchange Act. The Commission also ordered that Magna include a summary of the matters set forth in the Order in proxy solicitation materials to be filed with the Commission and sent to its shareholders in connection with a planned special meeting of shareholders. Magna consented to the Order without admitting or denying the findings or allegations therein.

The Commission stated in the Order that a former President of Magna, over a period of several years, received significant advances and other benefits without review and approval and which involved erroneous entries in Magna's books and records. The Commission stated that such advances and benefits were not disclosed or were inadequately disclosed in proxy statements and in periodic reports filed with the Commission and in materials sent to investors. CIVIL PROCEEDINGS

ZOE PRODUCTS, INC. AND JAMES P. MACPHERSON ENJOINED ON FRAUD CLAIM

The Los Angeles Regional Office announced that on May 24 a judgment of permanent injunction was entered against Zoe Products, Inc. and James P. MacPherson by U.S. District Court Judge James M. Ideman following the Commission's Motion for Summary Judgment.

The Court found, as alleged in the Commission's complaint, that Zoe and MacPherson violated Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 and Zoe violated, and MacPherson aided and abetted the violation of, Section 15(d) of the Exchange Act and Rules 12b-20 and 15d-11.

The Court, stating that Zoe and MacPherson appear to be frauds who have defrauded the public, found that they violated the above-referenced Sections by: (1) issuing press releases to the marketplace and filing reports with the Commission which falsely and misleadingly represented the status of sales of Zoe's "Country Naturals" vitamin products; (2) causing a newsletter to disseminate false and misleading information to the marketplace regarding Zoe's profitability and future success in selling its vitamins; and (3) purchasing and distributing to the marketplace reprints of the newsletter containing the false and misleading information.
