#### ADMINISTRATIVE PROCEEDINGS

Issue 85-144

NASD'S BAR FROM ASSOCIATED WITH A MEMBER FIRM AFFIRMED

The Commission affirmed the NASD's action that, in effect, barred certain persons from association with Exchange Services Inc. (ESI), an NASD member. ESI argued that its associated persons, employed as order takers, were exempt from the registration requirements of Part III of Schedule C of the NASD By-Laws because the limited nature of their duties fit within the exemption in Part V of Schedule C. Alternatively, ESI asserted that the limited nature of the duties performed by the associated persons should entitle them to a waiver of the examination requirement.

The NASD did not allow the order takers to become associated with ESI under Part V of Schedule C because it determined that they perform duties beyond the scope allowed under Part V of Schedule C and the associated persons were not eligible for a waiver of the examination requirement of Schedule C. The NASD concluded that, based on the failure of the order takers to comply with Schedule C of the By-Laws, the order takers could not be associated with ESI.

The Commission found that the NASD applied Schedule C in a manner consistent with the purposes of the Act. (Rel. 34-22245)

### **CIVIL PROCEEDINGS**

COMPLAINT NAMES CONTEXT INDUSTRIES, INC.

The Commission filed a civil injunctive action on July 24 in the U.S. District Court for the District of Columbia against Context Industries, Inc. of Miami, Florida. The complaint alleges violations of the reporting provisions of the securities laws and seeks a Judgment of Permanent Injunction and Other Equitable Relief.

The Commission alleges that Context, as part of a continuing course of violative conduct, failed to file its Annual Report on Form 10-K for its fiscal year ended December 31, 1984, and its Quarterly Report on Form 10-Q for its fiscal quarter ended March 31, 1985. The Commission requests that the Court order Context to file its delinquent Annual and Quarterly Reports and enjoin it from further violations of the reporting provisions of the securities laws. # **CRIMINAL PROCEEDINGS**

TWENTY-YEAR SENTENCE FOR SECURITIES LAW VIOLATOR

The Seattle Regional Office announced that on June 28 Judge Walter McGovern, U.S. District Court for the Western District of Washington, sentenced Harry Herbert March to four consecutive five year sentences upon conviction on counts of wire fraud, securities fraud (two counts) and mail fraud. As a result of conviction on a count of interstate transportation of stolen property, March was placed on probation to begin after his prison sentence and ordered to pay restitution to his victims of \$180,894. The sentence stemmed from a criminal trial occasioned by a fraudulent commodities investment scheme which March ran from 1982 through 1984. (U.S. v. Harry Herbert March, CR85-44M). (LR-10831)

# INVESTMENT COMPANY ACT RELEASES

PRUDENTIAL-BACHE SECURITIES INC.

A notice has been issued giving interested persons until August 19 to request a hearing on an application by Prudential-Bache Securities Inc. for an order exempting existing and future Prudential-Bache Mutual Funds from the provisions of Section 22(d) of the Investment Company Act to permit the proposed waiver of a contingent deferred sales load on certain redemptions of their shares. FRANKLIN LAKESHORE LIMITED PARTNERSHIP

A notice has been issued giving interested persons until August 19 to request a hearing on an application by Franklin Lakeshore Limited Partnership and its general partner, Milk Street Residential Limited Partnership IV, for an order exempting the Partnership from all provisions of the Investment Company Act. ### TRUST INDENTURE ACT RELEASES

#### ITT FINANCIAL CORPORATION

A notice has been issued giving interested persons until August 19 to request a hearing on an application by ITT Financial Corporation under Section 310(b)(1)(ii) of the Trust Indenture Act of 1939. The application declares that the trusteeship of BankAmerica Trust Company of New York (BATNY), under the following indentures qualified under the Act, is not so likely to involve a material conflict of interest as to make it necessary to disgualify BATNY from acting as trustee under such indentures. The indentures are: (1) an ITT indenture dated July 1, 1983 relating to debt securities to be issued by ITT from time to time, and a supplement thereto dated November 15, 1984 (as supplemented, the Shelf Indenture), under which ITT issued its 11-3/8% senior notes, due November 15, 1987; and (2) an indenture dated June 15, 1976 between ITT and Manufacturers Hanover Trust Company relating to ITT's 9-5/8% senior debentures, due June 15, 1996, for which BATNY accepted the successor trusteeship from Manufacturers on December 28, 1983 (the 1976 Indenture).
