COMMISSION ANNOUNCEMENTS

U.S. SECURITIES AND EXCHANGE COMMISSION

CAROLYN B. LEWIS NAMED ASSISTANT DIRECTOR

Carolyn B. Lewis has been appointed an Assistant Director in the Division of Investment. In her new position, Ms. Lewis will direct the operations of the Division's Office of Disclosure Policy and Review which is responsible for review and processing of registration statements and other disclosure documents filed by investment companies.

A graduate of the Hampton Institute in Virginia where she majored in accounting and economics, Ms. Lewis has extensive experience with both the federal securities laws and disclosure matters. Ms. Lewis joined the Commission staff in 1962 as a financial analyst in the Division of Corporate Regulation. Since then, she has been responsible for the analysis and review of the full range of investment company filings, serving first as a staff-level financial analyst and later, as a branch chief and the senior financial analyst in Investment Management's Disclosure Office. She was named Acting Assistant Director in June of this year.

ADMINISTRATIVE PROCEEDINGS

CHARLES J. WALSH, OTHERS SANCTIONED

The Commission entered Findings and Order by Default in an administrative proceeding under the Securities Exchange Act of 1934 and Investment Advisers Act of 1940 revoking the broker-dealer registration of Charles Walsh Securities Corp. (Securities) and the investment adviser registration of Charles Walsh & Partners, Inc. (Partners), and permanently barring Charles J. Walsh from association with any broker-dealer or investment adviser.

The Commission's Order found, based on the June 27 Order for Proceedings, that Walsh was convicted of federal wire fraud and District of Columbia false pretenses charges on March 29, and that Securities and Partners, wilfully aided and abetted by Walsh, had violated certain financial and supplemental reporting provisions of the Exchange and Advisers Acts.

In view of the failure of Securities, Partners and Walsh to answer the Order for Proceedings or file a Notice of Appearance, they were found in default and the allegations in the Order for Proceedings were deemed to be true in accordance with the Commission's Rules of Practice. (Rel. 34-22313)

INVESTMENT COMPANY ACT RELEASES

MERRILL LYNCH CALIFORNIA MUNICIPAL SERIES TRUST

A notice has been issued giving interested persons until September 9 to request a hearing on an application by Merrill Lynch California Municipal Series Trust (Applicant) for an order granting exemption from Sections 2(a)(32), 2(a)(35), 2(a)(41), 22(c) and 22(d) of the Investment Company Act and Rule 22c-1. The exemption will permit the levy (and waiver in certain cases) of a contingent deferred sales charge on certain redemptions of shares of Applicant's Merrill Lynch California Tax-Exempt Fund. (Rel. THE GUARDIAN INSURANCE & ANNUITY COMPANY, INC.

A notice has been issued giving interested persons until September 13 to request a hearing on an application filed by The Guardian Insurance & Annuity Company, Inc. and The Guardian Separate Account B for an order granting exemptions from the provisions of Sections 9(a), 12(d)(1), 13(a), 15(a), 15(b), 26(a)(2) and 27(c)(2) of the Investment Company Act and Rule 6e-2(b)(15). The exemption would permit the Account to offer single premium variable life insurance contracts funded by a unit investment trust comprised of stripped U.S. Treasury securities, and to permit "mixed funding" of variable life insurance contracts and variable annuity contracts from the same underlying management investment companies. RYLAND ACCEPTANCE CORPORATION FOUR
