COMMISSION ANNOUNCEMENTS

DOUGLAS SCARFF NAMED ADMINISTRATOR, BOSTON REGIONAL OFFICE

> The Commission today announced the appointment of Douglas Scarff as Administrator of the Boston Regional Office. Mr. Scarff is currently a partner with the firm of Lane and Edson, P.C. Prior to joining the firm, Mr. Scarff served as Director of the Commission's Division of Market Regulation from 1979 until 1984. Mr. Scarff received his B.A. from Dartmouth College in 1966. After obtaining his law degree from Michigan Law School in 1969, he became associated with the firm of Shearman & Sterling. Mr. Scarff initially joined the staff of the Commission in 1976.

THOMAS C. NEWKIRK NAMED CHIEF LITIGATION COUNSEL, DIVISION OF ENFORCEMENT

The Commission today announced the appointment of Thomas C. Newkirk as Chief Litigation Counsel in the Division of Enforcement. Mr. Newkirk is currently Chief Counsel for Judicial Litigation in the U.S. Department of Energy and formerly served there as Deputy General Counsel for Enforcement and Litigation and as Deputy General Counsel for Regulation. Prior to joining the Department of Energy in 1978, Mr. Newkirk was an attorney in the Office of Legal Counsel in the Department of Justice, and was Assistant Counsel on the Securities Industry Study conducted in 1972 and 1973 by the Subcommittee on Banking, Housing, and Urban Affairs. Mr. Newkirk, after receiving his LL.B. with distinction from Cornell Law School in 1966, practiced corporate and securities law with a law firm in New York and Washington prior to joining the Department of Justice in 1975.

CIVIL PROCEEDINGS

FINAL JUDGMENT OF PERMANENT INJUNCTION ENTERED AGAINST VERNON BROWNSTONE; PRELIMINARY INJUNCTION ENTERED AGAINST WESTERN GOLD, INC., OTHERS

The Atlanta Regional and Miami Branch Offices announced that on November 14 U.S. District Judge Thomas E. Scott, Southern District of Florida, entered a Final Judgment of Permanent Injunction against Vernon Brownstone and a Preliminary Injunction against Western Gold, Inc., U.S. Exploration Corporation, Professional Marketing Consultants, Inc. and Ronald Nagorniak. The Injunctions enjoin the defendants from violating the broker-dealer registration, antifraud and registration provisions of the securities The Court also entered an Order freezing the assets of Western Gold, U.S. laws. Exploration, Professional and Nagorniak. Brownstone consented, without admitting or denying the complaint's allegations, to the Final Judgment of Permanent Injunction.

The November 6 complaint alleges that Western Gold, U.S. Exploration, Professional and Nagorniak, aided and abetted by Brownstone, sold unregistered securities in the form of mineral aggregate piles coupled with development agreements for the extraction of gold and silver from the piles. The complaint alleges that the defendants made material misrepresentations to investors and potential investors. (SEC v. Western Gold, Inc., et al., Civil Action No. 85-3506-CIV-SCOTT, SDFL).
