ENFORCEMENT PROCEEDINGS

SETTLEMENT OFFER OF H.I. GLASS & COMPANY ACCEPTED

The Commission announced the entry of an Order Instituting Public Administrative Proceedings, Making Findings and Imposing Remedial Sanctions against H.I. Glass & Company and accepting Glass & Co.'s Offer of Settlement.

Glass & Co. consented to the issuance of the Order without admitting or denying the Commission's findings except as to the entry of an Order of Permanent Injunction against it, which it admitted. The Order finds that on July 21, 1993 the United States District Court for the Northern District of Ohio permanently enjoined Glass & Co. from future violations of the antifraud and other provisions of the federal securities laws. The complaint alleged that between 1986 and 1989, Glass & Co., a registered investment adviser, and Herbert I. Glass, its control person, sold securities in the form of investment partnership interests, and in connection therewith, reimbursed Glass & Co. approximately \$200,000 from investor funds for expenses not related to the operation of the partnerships. The complaint further alleged that Glass & Co., through Glass, improperly entered into a performance fee agreement and, between 1986 and 1988, received approximately \$1,500,000 in illegal performance fees.

The Commission's Order revokes Glass & Co.'s registration as an investment adviser. See also LR-13630 and LR-13767. (Rel. IA-1398)

RICHARD GALLAGHER ORDERED TO PERMANENTLY CEASE AND DESIST

The Commission has instituted and simultaneously settled administrative proceedings against Richard J. Gallagher (Gallagher), a Virginia resident and former chief financial officer of Star Technologies, Inc. (Star). Gallagher consented to entry of an order finding that he violated Section 10(b) of the Securities Exchange Act of 1934 (Exchange Act) and Rule 10b-5 thereunder and aided and abetted Star's violations of Section 13(a) of the Exchange Act and Rules 12b-20, 13a-1, and 13a-13 thereunder. The violations occurred in connection with the materially false and misleading periodic reports filed by Star with the Commission on Form 10-K for fiscal 1989 and on Form 10-Q for the first quarter of fiscal 1990. The Commission's order directs Gallagher to permanently cease and desist from committing or causing violations of Sections 10(b) and 13(a) of the Exchange Act and Rules 10b-5, 12b-20, 13a-1, and 13a-13 thereunder. PROCEEDINGS INSTITUTED AGAINST THE BANK OF BOSTON CORPORATION

The Commission announced that it has instituted public administrative proceedings pursuant to Section 21C of the Securities Exchange Act of 1934 against the Bank of Boston Corporation (BOB). The Order Instituting Public Administrative Proceedings alleges that BOB violated Section 13(a) of the Exchange Act and Rules 12b-20 and 13a-13 thereunder in connection with the filing of its Form 10-Q for the second quarter ended June 30, 1989 of its fiscal year ended December 31, 1989. Specifically, the Order alleges that in its Management's Discussion and Analysis of Financial Condition and Results of Operations (MD&A) in the second quarter 1989 Form 10-Q, BOB misstated or failed to properly disclose material facts and known trends and uncertainties concerning the deterioration of its loan portfolio which BOB reasonably could expect would have a material unfavorable impact upon its financial condition and results from operations.

A hearing will be scheduled to determine if the staff's allegations are true and, if so, what, if any, remedial action is appropriate. (Rel. 34-33454)

JUDGMENT OF DISGORGEMENT AGAINST CLARK BADER

On December 15, 1993, Chief Judge Judith N. Keep of the United States District Court for the Southern District of California entered a Final Judgment of Disgorgement Against Clark R. Bader (Bader), to which he consented. Pursuant to an earlier order granting the Commission summary judgment of disgorgement, Bader was ordered to pay \$26,943 plus \$18,661.51 in prejudgment interest. When he failed to pay, the Commission filed a motion for contempt. Based on his demonstrated inability to pay the entire amount of disgorgement, the Commission waived all but \$15,500 of the judgment.

The complaint, filed August 16, 1990, charged Bader and six other defendants with selling unregistered securities in connection with a purported factoring operation. The defendants were variously charged with making false and misleading statements and misappropriating investor funds.

Bader was permanently enjoined in November, 1990 pursuant to his consent (LR-12704). Bader has also been barred by the Commission from associating with any broker, dealer, municipal securities dealer, investment company or investment adviser (Rel. 34-29012). The Commission has obtained judgments of disgorgement against each of the remaining six defendants, all of whom have been permanently enjoined pursuant to their consents. [SEC v. Donald D. Bader, et al., Civ. Action No. 90-1135 K, LSP, S.D. Cal.] (LR-13448)
