## COMMISSION ANNOUNCEMENTS

DIVISION OF ENFORCEMENT WARNS OF POSSIBLE PRIME BANK FRAUD IN CONNECTION WITH BANKA BOHEMIA SECURITIES

Recently, the Commission and the federal financial institutions supervisory agencies warned the investment and financial institution communities regarding the escalation in the number of possibly fraudulent schemes involving the issuance, trading or use of so-called "prime" bank and similar financial instruments. On March 11, the Division of Enforcement issued an alert due to the receipt of information that indicates that there may be ongoing fraudulent attempts to sell approximately \$600 million in face value of "Prime Bank Guarantees" or "Bank Guarantees" (Prime Bank Securities) that were issued by Banka Bohemia, A.S., a bank located in Prague, Czech Republic. The Prime Bank Securities are written in English, bear no interest, vary in maturity dates and have face amounts ranging from \$1 million to \$25 million. The Prime Bank Securities have been offered and sold to at least one investor in the United States. (Press Rel. 94-14)

# ENFORCEMENT PROCEEDINGS

ADMINISTRATIVE PROCEEDINGS INSTITUTED AGAINST ROBERT WESTON AND RICHARD MORROW AND CEASE-AND-DESIST PROCEEDINGS INSTITUTED AGAINST MORROW

The Commission announced that it instituted public administrative proceedings against Robert Weston (Weston) of West Long Branch, New Jersey and Richard H. Morrow of Secaucus, New Jersey, pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 (Exchange Act), and against Weston pursuant to Sections 203(e) and 203(f) of the Investment Advisers Act of 1940, and instituted cease-and-desist proceedings against Morrow pursuant to Section 8A of the Securities Act of 1933 and Section 21C of the Exchange Act. Weston and Morrow are alleged to have violated the antifraud provisions of the federal securities laws while participating in a minimum-maximum,

private placement offering of limited partnership interests in Park Florida Associates, Ltd. Weston and Morrow distributed offering memoranda containing false and misleading statements of material fact concerning commissions and failed to disclose their actual compensation arrangements. In addition, Weston and Morrow failed to close the offering and promptly return investor funds after the offering failed to sell the specified minimum number of units by the specified offering closing date. ## DECISION BARRING SHAW AHMADI-TEHRANI FINAL

The decision of an administrative law judge barring Shaw Ahmadi-Tehrani from association with any broker or dealer has become final. In April 1993, Ahmadi-Tehrani was permanently enjoined, with his consent, from violating antifraud and disclosure provisions of the securities acts. The Commission's complaint in that action charged that Ahmadi-Tehrani engaged in a scheme to manipulate the price of Southland Communications, Inc. securities. In May 1993, Ahmadi-Tehrani was convicted of conspiracy to defraud the United States and bank fraud. The indictment charged that Ahmadi-Tehrani engaged in a scheme to steal blank checks and obtain cash from banks by forging the signatures of account holders whose names appeared on those checks. ACTION FILED AGAINST CAMPBELL AND ASSOCIATES, INC., WILLIAM CAMPBELL, WILLIAM BURNS, GEORGE SCHNEIDER, LEE SHAW AND LOIS SHAW, JR.

The Commission today announced the filing of a Complaint For Civil Injunction and Other Equitable Relief on March 7 in the U.S. District Court for the Northern District of Texas against Campbell and Associates, Inc. (Associates), William Jones Campbell (Campbell), William Russell Burns, George Charles Schneider, Lee Shaw and Lois R. Shaw, Jr. (collectively, the defendants).

The complaint alleges that each defendant violated the antifraud and securities registration provisions of the federal securities laws, and that each defendant, except Associates, also violated the broker-dealer registration provisions of the federal securities laws. The complaint also seeks civil penalties and disgorgement from each defendant. According to the complaint, from at least January 1990 until December 1992, the defendants raised \$26.9 million from over 1,300 investors through the offer and sale of investment contacts in an affinity based "Ponzi" scheme in which investors lost at least \$12.5 million. The Commission also alleges that the defendants falsely claimed that investor funds would be invested in various construction contracts and that their principal would be guaranteed. The complaint further alleges that investor monies were used to repay prior investors, to pay salaries and commissions, and to support Campbell's extravagant personal lifestyle and other business ventures. ## CHARLES BAZARIAN CONVICTED PURSUANT TO A GUILTY PLEA

The Commission and Vicki Miles-LaGrange, U.S. District Attorney for the Western District of Oklahoma, announced that on March 4 Charles J. Bazarian of Oklahoma City, Oklahoma pleaded guilty to one count each of securities fraud, wire fraud, making false statements to the Federal Deposit Insurance Corp., money laundering and escape. The securities fraud and wire fraud counts relate to Bazarian's conduct with Remington Financial Group, Inc., a publicly-traded company.

On January 11, 1994, Bazarian was indicted on thirty-nine counts, twenty-three of which alleged violations of the federal securities laws. Bazarian escaped from prison in September 1992 after having been sentenced to three years incarceration upon revocation of his probation based upon the same facts involved in this indictment. An order has been issued granting the application of Commercial Net Lease Realty, Inc. to withdraw from listing and registration its Common Stock, \$0.01 Par Value, on the American Stock Exchange. (Rel. 34-33748)

APPROVAL OF PROPOSED RULE CHANGE AND ACCELERATED APPROVAL OF AMENDMENT TO PROPOSED RULE CHANGE

The Commission approved a proposed rule change (SR-PHLX-92-30) filed by the <u>Philadelphia Stock Exchange</u> and approved on an accelerated basis Amendment No. 2 to the proposed rule change relating to a PHLX proposal that enacts upon PHLX clearing members certain responsibilities to help ensure that good faith margin treatment is properly granted. Publication of the order is expected in the <u>Federal Register</u> during the week of March 14. (Rel. 34-33749)

# PROPOSED RULE CHANGE
