# AMENDMENTS TO FORM ADV

The Commission has issued a release adopting amendments to Form ADV and related rules under the Investment Advisers Act of 1940. The amendments require investment advisers sponsoring wrap fee programs to prepare a separate disclosure document or "brochure" for wrap fee program clients. #### ENFORCEMENT PROCEEDINGS

THE COMMISSION PERMANENTLY BARS ALAN KAPPEL FROM APPEARING AND PRACTICING BEFORE THE COMMISSION

The Commission announced today the institution of a proceeding pursuant to Rule 2(e) of the Commission's Rules of Practice against Alan Kappel, a certified public accountant, formerly employed by Frederick S. Todman & Co., a public accounting firm. Simultaneous with the institution of the proceeding, and without admitting or denying the Commission's findings, Kappel consented to the issuance of an Order Instituting Proceedings and Opinion and Order Pursuant to Rule 2(e) of the Commission's Rules of Practice. The Commission's Order denies Kappel the privilege of appearing and practicing before the Commission. Commission's Order finds that Kappel, as engagement partner, engaged in improper professional conduct in connection with the audits of General Technology Group Ltd.'s financial statements for 1986, 1987 and 1988. The Order finds that Kappel failed to comply with fundamental requirements of GAAs in those audits, such as the requirement that audits be adequately planned, staffed and supervised, that persons conducting an audit be independent of the company whose financial statements are being audited; that a company's prior auditors be consulted concerning the reasons for their resignation; and that sufficient competent evidential matter be gathered concerning the existence and value of a company's inventory and receivables. The Order also finds that Kappel engaged in improper professional conduct by failing to comply with specific requirements imposed by a prior Commission Order. (Rel. 34-33955; AAE Rel. 552)

#### INVESTMENT COMPANY ACT RELEASES

# THE ARCH FUND, ET AL.

An order has been issued on an application filed by The Arch Fund, et al. under Section 6(c) of the Investment Company Act for an exemption from Sections 2(a)(32), 2(a)(35), 18(f)(1), 18(g), 18(i), 22(c), and 22(d) of the Act and Rule 22c-1 thereunder. The order permits certain investment companies to issue multiple classes of shares representing interests in the same portfolio of securities and assess and, under certain conditions, waive a contingent deferred sales charge on redemptions of shares. The requested order supersedes a prior order. (Rel. IC-20237 - April 20)

# THE BRINSON FUNDS, ET AL.

A conditional order has been issued on an application filed by The Brinson Funds, et al. pursuant to Section 17(d) of the Investment Company Act and Rule 17d-1 thereunder permitting the operation of a joint trading account in repurchase agreements, with maturities not to exceed 60 days, "collateralized fully," as that term is defined in rule 2a-7 under the Act; U.S. Government securities with remaining maturities not to exceed 91 days; and other short-term money market instruments that constitute "Eligible Securities" within the meaning of Rule 2a-7 with remaining maturities not to exceed 90 day. # PIONEER INVESTMENT PLANS FOR THE ACCUMULATION OF SHARES OF THE PIONEER FUND

A notice has been issued giving interested person until May 16 to request a hearing on an application filed by Pioneer Investment Plans for the Accumulation of Shares of the Pioneer Fund under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. # KINGSPORT POWER COMPANY

An order has been issued authorizing Kingsport Power Company, an electric utility subsidiary company of American Electric Power Company,

Inc., a registered holding company, to issue and sell its unsecured notes in the aggregate principal amount of up to \$5 million outstanding at any one time, from time-to-time through June 30, 1995. (Rel. 35-26032)

# ENTERGY CORPORATION, ET AL.

A supplemental order has been issued authorizing Entergy Corporation (Entergy), a registered holding company, and its operating publicutility subsidiary companies, Arkansas Power & Light Company (AP&L), Louisiana Power & Light Company (LP&L), Mississippi Power & Light Company (MP&L), (collectively, Operating Companies), New Orleans Public Service Inc., System Energy Resources, Inc. (SERI), Entergy Operations, Inc., System Fuels, Inc., Entergy Services, Inc. and Gulf States Utilities Company, to finance their interim capital needs. The Operating Companies propose to issue short-term promissory notes to banks and commercial paper to dealers through November 30, 1994 (Short-Term Borrowing). The proposed borrowing limits are \$75 million for AP&L; \$75 for LP&L; and \$13 million for MP&L. The Commission shall continue to reserve jurisdiction, over Short-Term Borrowings, up to an aggregate principal amount of \$55 million for AP&L \$59 million for LP&L; and \$113 million for SERI, pending completion of the record. Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
