MEETING OF EXECUTIVE COMMITTEE OF THE GOVERNMENT-BUSINESS FORUM ON SMALL BUSINESS CAPITAL FORMATION

The Small Business Investment Incentive Act of 1980 requires the Commission to conduct an annual Government-Business Forum to review the current status of problems and programs relating to small business capital formation. The Executive Committee, comprised of appointees from several Federal agencies and private sector organizations, will meet on January 19, 1984, at 9:30 a.m. for the purpose of planning the Forum which is scheduled for the fall of 1984. The meeting is to be held at the Securities and Exchange Commission, Room 3059, 450 5th St., N.W., Washington, D.C. 20549, and will be open to the public.

CIVIL PROCEEDINGS

GEORGE C. BANGS ENJOINED

The Chicago Regional Office announced that on December 30, 1983, George C. Bangs (Bangs), a Connecticut resident, and Bangs Securities, Inc., a Chicago, Illinois broker-dealer registered with the Commission, were enjoined from further violations of the antifraud provisions of the securities laws in the offer and sale of oil and gas limited partnership interests or any other securities. Bangs is the sole proprietor of Bangs Securities, Inc., which was also enjoined from filing a false application for registration with the Commission and from failing to make its books and records available for inspection by Commission staff. Bangs consented to the injunctive relief requested without admitting or denying the allegations contained in the Commission's complaint. (SEC v. George C. Bangs, No. 83-C-1440, N.D. AMENDMENT NO. 1 TO PROPOSED RULE CHANGE

The New York Stock Exchange, Inc. filed Amendment No. 1 to a proposed rule change under Rule 19b-4 (SR-NYSE-83-52) to amend NYSE's proposed rules relating to options on industry indices and to revise the composition of certain of the specific industry index options the NYSE seeks authorization to trade. ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved, on an accelerated basis, a proposed rule change filed by the Pacific Stock Exchange, Inc. (SR-PSE-84-1) to extend the PSE's pilot program for the appointment and evaluation of specialists and the creation of new specialist posts until June 30, 1984.
