

#### **ADMINISTRATIVE PROCEEDINGS**

PROCEEDINGS INSTITUTED AND ORDER ISSUED AGAINST JAMES H. FELDHAKE, OTHERS

> The Commission issued an Opinion and Order in an administrative proceeding instituted under Rule 2(e)(1)(ii) of its Rules of Practice against James H. Feldhake, Randall R. Beeson and Richard A. Stewart, accountants in Fox & Company's Denver office. The Opinion and Order was issued in connection with Fox's audit and report on the financial statements of Alpex Computer Corp. for the fiscal year ended December 31, 1981. The Commission found that the respondents, who were primarily responsible for Fox's issuance of a materially false and misleading accountants' report, engaged in improper professional conduct by not conducting their examination of Alpex's 1981 financial statements in accordance with generally accepted auditing standards. These auditors recklessly failed to adhere to professional standards relating to the acceptance of new clients, audit planning, audit supervision, audit review, and the independent auditor's responsibility for the detection of irregularities, including misappropriation of assets and recording of trans-actions without substance. Respondents submitted Offers of Settlement in which they consented to an order containing certain findings and remedial sanctions without admitting or denying the Commission's findings. #### **CIVIL PROCEEDINGS**

FINES ASSESSED AGAINST THOMAS C. FITZGERALD, JR.; SPECIAL AGENT ORDERED

> The Commission announced that on April 9 the U.S. District Court for the District of Columbia entered an Order against Thomas C. Fitzgerald, Jr. of Atlanta, Georgia, the President and Chairman of the Board of Directors of Diversified Growth Corporation (DGC) and American Diversified Corporation (ADC), and against DGC and ADC.

The Order gave Judgment against Fitzgerald for fines of \$143,000 previously imposed against him for failure to comply with a June 20, 1983 Court order. The Court order held him in contempt and required him to pay fines of \$1,000 per day, beginning July 15, 1983, if specified reports were not filed with the Commission by that date. It also ordered the appointment of a Special Agent to cause complete and accurate annual and quarterly reports to be prepared for DGC and ADC under a Judgment of Permanent Injunction entered on June 8, 1983 [LR-10030]. The Special Agent is to be compensated out of the fines assessed and Fitzgerald will be required to compensate him and any other personnel for fees and expenses which exceed the amount of the fines assessed and to cooperate fully. (SEC v. Diviersified Growth Corporation, et al., USDC DC, Civil Action No. 81-0084, 1981). (LR-10335)

BISHOP, BALDWIN, REWALD, DILLINGHAM & WONG, INC. AND RONALD R. REWALD PERMANENTLY ENJOINED

> The Los Angeles Regional Office announced that on April 3 Judge Martin Pence, U.S. District Court for the District of Hawaii, entered orders of permanent injunction against Bishop, Baldwin, Rewald, Dillingham & Wong, Inc. (Bishop Baldwin) and Ronald R. Rewald from further violations of the antifraud provisions of the securities laws. The orders of permanent injunction do not affect the Commission's request for disgorgement, which, according to the settlement agreement, was left open pending resolution at a later date. Simultaneous with the settlement, Rewald withdrew his appeal to the Ninth Circuit Court of Appeals challenging the denial of his motion to modify the District Court's freeze order of his personal assets. Bishop Baldwin, a registered investment adviser located in Honolulu, Hawaii, and Rewald, its chairman of the board of directors, vice president and treasurer, consented to the orders of permanent injunction without admitting or denying the allegations in the complaint.

The complaint alleges that defendants, from at least January 1982 to August 1983, offered and sold investments in a tax-deferred Investment Savings Account (Account), which purportedly earned 20% per annum. The complaint further alleges that approximately \$17 million was raised by defendants from investors in several states and that in the offer and sale of investments in the Account, Rewald and Bishop Baldwin made material misrepresentation of fact and omitted to state other material facts to clients, prospective clients, investors and offerees concerning: Rewald's educational background; the existence of \$150,000 FDIC coverage for each individual's investment in the Account; Bishop Baldwin's business history; commissions paid to salespersons who referred investors into the Account; the risks of investing in the Account; the use of funds obtained from investors; and Bishop Baldwin's receipt of compensation in securities it recommended. An order has been issued exempting John Hancock U.S. Government Securities Fund, Inc. and John Hancock Distributors, Inc. from the provisions of Section 22(d) of the Investment Company Act. (Rel. IC-13872 - Apr. 9)

RETIREMENT PLANNING FUNDS OF AMERICA, INC.

A notice has been issued giving interested persons until May 3 to request a hearing on an application of Retirement Planning Funds of America, Inc. for an order: (1) exempting Applicant from the provisions of Sections 2(a)(32), 2(a)(35), 22(c) and 22(d) of the Investment Company Act and Rules 22c-1 and 22d-1 to permit it to assess (and waive in certain cases) a contingent deferred sales charge on redemptions of its shares; and (2) permitting certain exchange transactions. #### **SELF-REGULATORY ORGANIZATIONS**

NOTICE OF PROPOSED RULE CHANGES

The following filed proposed rule changes under Rule 19b-4: <u>The Pacific Stock</u> <u>Exchange, Inc.</u> (SR-PSE-84-7) to: (1) establish standards for the securities comprising indices on which options are traded; (2) codify position and exercise limits for both broad- and narrow-based index options; and (3) establish standards for determining when an index option is broad-based. (Rel. 34-20840); and <u>The Midwest</u> <u>Securities Trust Company</u> (SR-MSTC-84-2) to establish MSTC as a "qualified securities depository" for purposes of Securities Exchange Act Rule 17Ad-14. If approved, the proposed rule change would effectively require registered transfer agents subject to Rule 17Ad-14 to establish an account at MSTC for securities deliveries during tender and exchange offers specified in Rule 17Ad-14. The proposed rule change would also specify procedures for book-entry deliveries to and from the bidder's agent during certain tender offers. (Rel. 34-20842)

Publication of the proposals are expected to be made in the <u>Federal Register</u> during the week of April 9.

AMENDMENT TO PROPOSED RULE CHANGE

The American Stock Exchange, Inc. filed an amendment to a proposed rule change (SR-Amex-82-27) to permit Amex options specialty firms to: (1) perform certain types of research and advisory services respecting stocks underlying the specialty firms specialty options; and (2) participate as selling group members in underwritings of non-convertible senior securities of issuers of the securities underlying the specialty firm's specialty options. Publication of the proposal is expected to be made in the Federal Register during the week of April 16. (Rel. 34-20841)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the New York Stock Exchange, Inc. The rule change (SR-NYSE-84-7) increases the charge to the NYSE's members and member organizations for regulatory oversight services for \$0.13 to \$0.26 per \$1,000 of total revenues as reported in the FOCUS reports. Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
