RULES AND RELATED MATTERS

ADOPTION OF AMENDMENTS TO RULES 485(b) AND 486(b)

The Commission adopted amendments to Rules 485(b) and 486(b) under the Securities Act of 1933 which permit certain post-effective amendments filed by open-end investment companies and unit investment trusts to become automatically effective immediately upon filing without prior staff review. The amendments to the Rules will permit post-effective amendments filed solely for the purpose of complying with an undertaking to file an amendment containing financial statements, within four to six months after the effective date of the registrant's Securities Act registration statement, to become automatically effective immediately upon filing or on any subsequent day through the twentieth day after the date of filing designated by the registrant. The amendments where adopted in order to permit the Division of Investment Management to make more efficient use of its resources, and avoid delay in processing investment company filings. ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST DENNIS R. RONCACE

The Commission instituted public administrative proceedings against Dennis R. Roncace, a former registered representative of a broker-dealer registered with the Commission. In anticipation of these proceedings, Roncace submitted an Offer of Settlement which the Commission accepted. In the Offer of Settlement, Roncace consented to an Order

Instituting Proceedings, Making Findings and Imposing Remedial Sanctions which finds that he, without admitting or denying the allegations of the Order, wilfully violated antifraud provisions of the securities laws in options transactions in his customers' accounts. In accepting the Offer of Settlement, the Commission barred Roncace from association with any broker, dealer, investment company, investment adviser or municipal securities dealer. (Rel. 34-20887)

INVESTMENT COMPANY ACT RELEASES

BMC FUND, INC.

A notice has been issued giving interested persons until May 25 to request a hearing on an application filed by BMC Fund, Inc., a registered closed-end investment company, requesting an order permitting BMC to repurchase up to 5.7 percent of its shares from the Broyhill Foundation, an affiliated person of BMC. RETIREMENT PLANNING FUNDS OF AMERICA, INC.

An order has been issued exempting Retirement Planning Funds of America, Inc. from the provisions of Sections 2(a)(32), 2(a)(35), 22(c) and 22(d) of the Investment Company Act and Rules 22c-1 and 22d-1 to permit it to assess (and waive in certain cases) a contingent deferred sales charge on redemptions of its shares, and permitting certain exchange transactions. SELF-REGULATORY ORGANIZATIONS

NOTICE OF PROPOSED RULE CHANGE

The New York Stock Exchange, Inc. filed a proposed rule change (SR-NYSE-84-17) to increase the position and exercise limits for broad-based index options to 80,000 contracts. The proposed rule would also change the basis for setting the limits from a dollar value to a fixed number of contracts. Publication of the proposal is expected to be made in the Federal Register during the week of May 7. (Rel. 34-20925)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the Pacific Stock Exchange, Inc. The rule change (SR-PSE-84-5) would amend PSE's listing fee schedule by adopting a refund policy under which the Exchange would return all but 25 percent of the listing fee paid by an issuer that withdraws an original or additional listing application either before the Exchange has acted to approve or disapprove the application or after the Exchange has disapproved it.
