ADMINISTRATIVE PROCEEDINGS

THOMAS J. FURNARI BARRED

The Commission barred Thomas J. Furnari, an Oak Park, Illinois securities salesman, from association with any broker or dealer. The Commission's order provides that, after one year, Furnari may become so associated in a non-supervisory and non-proprietary capacity, upon a satisfactory showing that he will be adequately supervised.

The Commission found that, during 1979 and 1980, Furnari induced four customers to invest in a collateralized options writing program by means of fraudulent representations concerning the risks involved in the program, the anticipated rate of return, and the asserted success Furnari had enjoyed with other accounts in the program. The Commission also found that, after the customers had invested in his program, Furnari misled them as to the status of their accounts, telling them they were earning profits when in fact they were suffering substantial losses.

In affirming the sanction imposed on Furnari by an administrative law judge, the Commission stated that Furnari's actions manifested "a blatant indifference to the obligation of fair dealing borne by those in the securities business," and that a lesser remedy would not suffice "in light of his egregious misconduct." STEPHEN O. WADE, OTHERS CITED

The Commission today instituted administrative proceedings against Stephen O. Wade of Matthews, North Carolina, Ralph H. Newton, Jr. of Charlotte, North Carolina, and Clark C. Burritt, Jr. of Greensboro, North Carolina, under Rule 2(e) of the Commission's Rules of Practice. Wade, Newton and Burritt are certified public accountants.

Simultaneously with the institution of these proceedings, Wade, Newton and Burritt submitted Offers of Settlement and Undertakings. Under the terms of the Offers, Wade, Newton and Burritt, without admitting or denying the factual assertions, findings or conclusions set forth in the Commission's Opinion and Order, consented to the Commission's Opinion and Order.

The Commission's Opinion and Order states that Newton and Wade caused the issuance of an unqualified audit opinion and an unqualified review report on the financial statements of two savings and loans, which financial statements reported deferral of losses on certain futures transactions, even though generally accepted accounting principles did not permit such deferral. Prior to issuing their audit opinion, Wade and Newton consulted Burritt who failed to ensure that the futures transactions were properly accounted for.

The Commission accepted the respondents' Offers and ordered their censure. Additionally, the Commission ordered that Wade and Newton fully comply with their undertakings, that for three years, Wade and Newton will not be, directly or indirectly, involved in any audit engagement of any entity or company whose financial statements are reasonably expected to be filed with the Commission. The Commission extended to July 16 the time for submitting comments respecting proposed rule changes to trade options on over-the-counter securities (SR-NASD-80-10), Amex-83-33, CBOE-83-53, NYSE-84-4, PSE-84-2, and Phlx-83-27), and a proposed rule change submitted by the New York Stock Exchange, Inc. (SR-NYSE-84-3) to trade options on individual listed stocks. (Rel. 34-21089)
