EXCHANGE COMMISSION

AMERICAN PRINCIPAL HOLDINGS, INC. TEMPORARILY RESTRAINED; TEMPORARY RECEIVER APPOINTED

The Los Angeles Regional Office announced that on June 15 Judge Leland C. Nielsen, Southern District of California, entered orders temporarily restraining and enjoining American Principals Holding, Inc. (APHI), a holding company located in Del Mar, California, from further violations of the registration and antifraud provisions of the securities laws. Judge Nielsen appointed Ashley S. Orr, San Diego County attorney, temporary receiver for the assets of APHI. (Judge J. Lawrence Irving, Southern District of California, sat by designation at the hearing.) Judge Nielsen also entered an order to show cause why the temporary receiver should not be appointed permanently and set the matter for hearing on June 26, 1984.

The Commission's June 7 complaint alleges that from 1979 through March 31, 1984, APHI violated the registration and antifraud provisions in the sale of approximately \$70 million of non-exempt, unregistered limited partnership interests in real estate, windmills, horsebreeding and equipment leasing and related debentures to 2,500 investors nationwide. APHI allegedly made the sales through seven subsidiaries. The offering purportedly provided substantial tax advantages as well as long-term capital gains and current income to investors.

The court orders do not affect Private Ledger Financial Services, Inc., a wholly-owned subsidiary of APHI and a registered broker-dealer, or directors of APHI elected on or after March 29, 1984. (SEC v. American Principals Holdings, Inc., SDCA, Civil Action No. 84-1383-N[M]). (LR-10431)

### TELEFILE COMPUTER CORPORATION ENJOINED

The Commission announced that on June 29 the U.S. District Court for the District of Columbia entered a Final Judgment of Permanent Injunction against Telefile Computer Corporation of Irvine, California. The Judgment enjoined Telefile from failing to file periodic reports and Notifications of Late Filing on time.

The Commission's February 2 complaint alleged that Telefile, as part of a continuing course of conduct, failed to file its Annual Report on Form 10-K for its fiscal year ended September 30, 1983, various periodic reports in a timely manner, and required Notifications of Late Filing on Form 12b-25 respecting certain of its late periodic reports. Telefile, consenting to the Court's Judgment, admitted that it had failed to timely file annual and quarterly reports and failed to file Notifications of Late Filing. (SEC v. Telefile Computer Corporation, USDC DC, Civil Action No. 84-0355). (LR-10439)

### INSIDER TRADING CASE FILED

The Seattle Regional Office announced that on June 6 a complaint was filed and a decree of permanent injunction and disgorgement of all profits was entered by consent in the U.S. District Court for the Eastern District of Washington against David Spiker and William Peterson, two Spokane brokers, and Norm Brock, an attorney in a Spokane law firm, for violations of the antifraud provisions of the Securities Exchange Act of 1934 arising out of their trades while in possession of material non-public information. Peterson and Spiker consented possession while admitting the complaint's allegations. Brock neither admitted nor denied the allegations. The Court ordered disgorgements amounting to \$96,400. (SEC v. David Spiker, et al., USDC EDWA, No. 84-429-RJM). (LR-10444)
