RULES 26a-1 AND 26a-2 ADOPTED

The Commission adopted Rules 26a-1 and 26a-2 under the Investment Company Act of 1940 which, respectively, implement the Commission's authority to prescribe reasonable administrative fees for unit investment trusts and permit insurance company separate accounts to engage in certain custodianship activities and make certain deductions from account assets. ## CIVIL PROCEEDINGS

### AMERICAN PRINCIPALS HOLDINGS, INC. PERMANENTLY ENJOINED

The Los Angeles Regional Office announced that on June 29 Judge Leland C. Nielsen, Southern District of California, entered an Order of Permanent Injunction against American Principals Holdings, Inc. (APHI), a holding company located in Del Mar, California, from further violations of the registration and antifraud provisions of the securities laws. APHI consented to the Order without admitting or denying the complaint's allegations. Previously, on June 26, Judge Nielsen appointed Ashley S. Orr, a San Diego County attorney, as permanent receiver of APHI's assets.

The June 7 complaint alleges that APHI: from 1979 through March 31, 1984, violated the registration and antifraud provisions in the sale of approximately \$70 million of non-exempt unregistered limited partnership interests in real estate, wind power, horsebreeding, equipment leasing and debentures to 2,500 investors nationwide; made the sales through seven subsidiaries; and made material misrepresentations and omissions in connection with this offering. The offering purportedly provided substantial tax advantages as well as long-term capital gains and current income to investors.

The Orders do not affect Private Ledger Financial Services, Inc., a wholly-owned subsidiary of APHI and a registered broker-dealer, or directors of APHI elected on or after March 29, 1984. (SEC v. American Principals Holdings, Inc., SDCA, Civil Action No. 84-1383-N [M]). (LR-10466)

### HERSCHELL SAVILLE ENJOINED

The Atlanta Regional and Miami Branch Offices announced that on July 23 Judge Alcee L. Hastings, U.S. District Court for the Southern District of Florida, entered a Final Judgment of Permanent Injunction and Other Relief against Herschell Saville, also known as Herb Sands, of Miami, Florida, enjoining him from violating the registration and antifraud provisions of the Securities and Exchange Acts. Saville consented to the Final Judgment without admitting or denying the complaint's allegations.

Numerous public inquiries are received pertaining to the source of the Commission's Official Summary, commonly referred to as the "Insiders Report". The SEC "Official Summary" is a monthly summary of equity security transactions and holdings in publicly traded companies by officers, directors, and holders of more than 10% of the stock.

Saville was enjoined from making misrepresentations of material facts and omissions of material facts in the offer, purchase and sale of Sunco's fractional, undivided interests in oil and gas rights regarding the identity and experience of Sunco's principals and sales personnel, the production of Sunco's wells, and the risks inherent in this venture. Saville consented to disgorge an amount of money to be determined by the Court at a later hearing. (SEC v. Sunco Resource & Energy Ltd., Inc., et al., USDC SDFL, Civil Action No. 84-0618-CIV-ALH).
