## **ADMINISTRATIVE PROCEEDINGS**

### REGISTRATION OF CORPORATE REGISTRAR AND TRANSFER COMPANY REVOKED

In connection with public administrative proceedings previously instituted under Section 17A(c)(3)(A) of the Securities Exchange Act of 1934, the Commission revoked the registration of Corporate Registrar and Transfer Company, a registered transfer agent. Corporate Registrar consented to the Order without admitting or denying the allegations contained in the Order for Proceedings.

The Commission found that from October 1980 through June 1983, Corporate Registrar wilfully violated Sections 17(a), 17(f)(2) and 17A(d) of the Exchange Act and Rules 17f-2, 17Ad-2, 17Ad-3, 17Ad-6 and 17Ad-7 by failing to: make and keep required books and records; turnaround routine items as required; send required written notices during periods of substandard turnaround performances; restrict the addition of new client issuers during periods of substandard turnaround performance; and fingerprint employees. (Rel. 34-21168)

## CIVIL PROCEEDINGS

#### COMPLAINT FILED AGAINST LONGHORN OIL & GAS CO., OTHERS

The Fort Worth Regional Office filed a complaint on August 1 in the Western District of Oklahoma against J. D. Allen, John Lang, William G. Patterson, Carl W. Swan, Longhorn Oil and Gas Company (Longhorn), Longhorn Gas Programs Inc. and Longhorn Petroleum Company, Inc., all of Oklahoma City, Oklahoma. The complaint seeks an order to permanently enjoin the defendants from further violations of the registration and antifraud provisions of the securities laws.

The complaint alleges that Allen, Lang, Patterson, Swan, Longhorn and two of its subsidiaries violated the registration provisions by raising approximately \$66 million from the offer and sale of limited partnerships to over 300 investors residing in 25 states. Longhorn offered and sold interests in nine leveraged tax sheltered limited partnerships from 1978 through 1981, which were formed to invest in oil and gas properties. The complaint also alleges that in the offers and sales of limited partnership interests, Allen, Swan, Lang and Patterson misrepresented and omitted to state certain material facts. (SEC v. J.D. Allen, et al., WD OK, Civil Action No. 84-1938E). (LR-10476)

## **INVESTMENT COMPANY ACT RELEASES**

### FOREST CITY INVESTMENT PARTNERS I LIMITED PARTNERSHIP

A notice has been issued giving interested persons until August 27 to request a hearing on an application of Forest City Investment Partners I Limited Partnership and its general partner, Forest City Dillion, Inc., for an order exempting the Partnership from all provisions of the Investment Company Act. #### THE BOSTON COMPANY FUND

An order has been issued exempting The Boston Company Fund, The American Express Funds, The Boston Company Advisers, Inc., American Express Company, and American Express Service Corp. from Section 17(a) of the Investment Company Act and, to the extent necessary, to implement the proposed reorganization. ### HOLDING COMPANY ACT RELEASES

#### CONSOLIDATED NATURAL GAS COMPANY

An order has been issued authorizing Consolidated Natural Gas Company (CNG), a registered holding company, and its subsidiaries, CNG Development Company (CNGD) and Consolidated Gas Transmission Corporation (Transmission), to convey oil and gas leases and fee properties from Transmission to CNGD, and releasing jurisdiction over service provisions. #### SOUTHERN ELECTRIC GENERATING COMPANY

A notice has been issued giving interested persons until August 29 to request a hearing on a proposal of Southern Electric Generating Company (SEGCO), subsidiary of Alabama Power Company and Georgia Power Company, each of which owns 50% of SEGCO's outstanding common stock, to issue and sell up to \$30 million of long-term notes outstanding at any one time. The National Association of Securities Dealers, Inc. filed the following proposed rule changes under Rule 19b-4: (SR-NASD-84-16) to amend the NASD's Code of Arbitration to conform to recent amendments to the uniform arbitration code developed by the Securities Industry Conference on Arbitration. (Rel. 34-21188); and (SR-NASD-84-18) to establish a new rate of \$2,000 per month, applicable to the receipt of the NASDAQ Level 1 quotation data stream for processing and use in an automated execution system. (Rel. 34-21191)

Publication of the proposals are expected to be made in the <u>Federal Register</u> during the week of August 6.

#### APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the American Stock Exchange, Inc. (SR-Amex-84-19) to amend Amex Rules 300 and 301 to require member firms to submit partnership agreements and amendments without the need for an Exchange request, and to amend Rule 341 to require member firms to receive Exchange approval only for those corporate officers authorized to legally bind the corporation.
