U.S. SECURITIES AND EXCHANGE COMMISSION

CHARLES BAUER, JR. ENJOINED

The Washington Regional Office announced that on December 3 U.S. District Court Chief Judge Alfred L. Luongo entered a Final Judgment and Order permanently enjoining Charles Bauer, Jr., doing business as Fraternal Society of Annuitants and Golden Eagle Annuities, from violations of the registration and antifraud provisions of the securities laws. Additionally, Bauer consented to pay over to the Registry of the Court for the Eastern District of Pénnsylvania the proceeds from two previously frozen accounts. These funds will be distributed to investors under a Plan of Distribution submitted by the Commission to the Court. Bauer consented to the permanent injunction without admitting or denying the complaint's allegations. (SEC v. Charles Bauer, Jr., d/b/a Fraternal Society of Annuitants and Golden Eagle Annuities, ED PA, Civil Action No. 84-4574). (LR-10625)

COMPLAINT NAMES RESOURCE ROYALTIES, INC., OTHERS

The Chicago Regional Office filed a complaint on December 3 in the U.S. District Court for the Eastern District of Missouri, Eastern Division, seeking to permanently enjoin Resource Royalties, Inc., Richard O. Laughlin, and Das W. Conway of the St. Petersburg, Florida area, and C. Wallace McPherson, of St. Louis, Missouri, from further violations of the registration and antifraud provisions of the securities laws. Additionally, the complaint seeks to enjoin Resource and McPherson from further violations of the reporting requirements of the securities laws.

The complaint alleges that: at different times from July 1981 through May 1983, the defendants sold over \$500,000 worth of unregistered Resource restricted stock to approximately 180 investors located primarily in Missouri, Illinois and Florida; in these sales, the defendants distributed false and misleading brochures, reports, and news articles, and failed to inform potential investors that the stock being sold was restricted and not freely tradeable; and Resource, aided and abetted by McPherson, made false filings with the Commission. (SEC v. Resource Royalties, Inc., et al., ED MO, Civil Action No. 84-2810.C-4). (LR-10626)

INVESTMENT COMPANY ACT RELEASES

NORWEST MORTGAGE CONVENTIONAL HOUSING 1, INC.

An order has been issued exempting Norwest Mortgage Conventional Housing 1, Inc. from all provisions of the Investment Company Act. (Rel. IC-14267 - Dec. 6)

SOUTHWESTERN APARTMENTS ASSOCIATES LIMITED PARTNERSHIP

A notice has been issued giving interested persons until December 26 to request a hearing on an application of Southwestern Apartments Associates Limited Partnership and Potomac Real Estate Group, Inc. for an order exempting the Partnership from all provisions of the Investment Company Act. (Rel. IC-14268 - Dec. 6)

HOLDING COMPANY ACT RELEASES

NORTHEAST UTILITIES

A supplemental order has been issued extending until December 31 the time for Northeast Utilities, a registered holding company, to issue and sell, in one or more sales, the remaining 1,500,000 shares of its common stock, \$5 par value, and also to continue to make capital contributions during the same period to its subsidiaries, Western Massachusetts Electric Company and The Connecticut Light and Power Company, of up to an aggregate of \$30 and \$70 million, respectively. (Rel. 35-23516 - Dec. 4)

GEORGIA POWER COMPANY

A supplemental order has been issued authorizing Georgia Power Company, subsidiary of The Southern Company, to enter into certain transactions related to \$40 million of financing for pollution control facilities for use in its Scherer plant. (Rel. 35-23517 - Dec. 4)

CONNECTICUT LIGHT AND POWER COMPANY

An order has been issued authorizing The Connecticut Light and Power Company (CL&P), subsidiary of Northeast Utilities, to finance certain pollution control facilities in the amount of \$12 million. (Rel. 35-23518 - Dec. 4)

An order has also been issued authorizing CL&P and Western Massachusetts Electric Company to issue and sell notes to banks maturing not later than July 10, 1988, in an aggregate amount not to exceed \$150 million outstanding at any one time. (Rel. 35-23520 - Dec. 5)

COLUMBIA GAS SYSTEM, INC.

An order has been issued authorizing Columbia Gas System, Inc., a registered holding company, to purchase seven shares of Big Marsh Oil Co. stock, Columbia's subsidiary, from Union National Trust of Pittsburgh, valued at \$1,947 per share. (Rel. 35-23519 ~ Dec. 5)

LOUISIANA POWER & LIGHT COMPANY

A supplemental order has been issued authorizing Louisiana Power & Light Company, subsidiary of Middle South Utilities, Inc., to issue and sell up to \$35 million of first mortgage bonds in one or more series not later than August 31, 1985. Jurisdiction has been reserved over the issuance and sale of an additional \$10 million of bonds as to which the record is incomplete. (Rel. 35-23521 - Dec. 6)

SELF-REGULATORY ORGANIZATIONS

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the New York Stock Exchange, Inc. (SR-NYSE-84-20) to amend the NYSE's Arbitration Rules. Among the modifications, "simplified arbitration" procedures will apply to claims not exceeding \$500, instead of claims not exceeding \$2,500, filing fees will be raised and an NYSE member organization will be required to pay a non-refundable filing fee of \$500, in addition to all other fees, when filing a claim against a non-member. (Rel. 34-21542)

NOTICE OF PROPOSED RULE CHANGES

The American Stock Exchange, Inc. filed the following proposed rule changes: (SR-Amex-84-36 to expand its Post Execution Reporting (PER) system to increase the limits on PER orders from 300 shares to 1,000 shares for market orders and from 500 shares to 1,000 shares for marketable limit orders, and to permit away-from-the market limit orders up to 10,000 shares. (Rel. 34-21543); and (SR-Amex-84-34) to amend Exchange Rules 920 and 922 relating, respectively, to the examination of sales personnel who handle debt options, and the supervision of these sales personnel by member organizations. (Rel. 34-21544)

Publication of the proposals are expected to be made in the Federal Register during the week of December 10.

TRUST INDENTURE ACT RELEASES

PULLMAN LEASING COMPANY AND PULLMAN RAIL LEASING INC.

An order has been issued under the Trust Indenture Act of 1939 on an application of Pullman Leasing Company and Pullman Rail Leasing Inc. (Applicant) that the successor trusteeship of Harris Trust and Savings Bank, under two indentures of Applicant, is not so likely to involve a material conflict of interest as to make it necessary to disqualify Harris from acting as successor trustee.
