ADMINISTRATIVE PROCEEDINGS

EXCHANCE COMMISSION

WALTER GREGORY FRIES BARRED

The Commission accepted an Offer of Settlement submitted by Walter Gregory Fries in public administrative proceedings previously instituted under Sections 15(b) and 19(h) of the Securities Exchange Act of 1934. In his Offer, Fries, without admitting or denying the allegations contained in the Commission's Order for Proceedings, consented to findings that he wilfully violated the antifraud provisions of the securities laws which involved a scheme whereby unauthorized trades were made in the account of a customer of a broker-dealer. Fries received at least \$75,000 in this scheme.

As a result of his Offer, Fries was barred from association with any broker, dealer, municipal securities broker, municipal securities dealer, investment adviser or investment company. (Rel. 34-21538)

BISHOP, BALDWIN, REWALD, DILLINGHAM & WONG INC.'S REGISTRATION REVOKED AND RONALD R. REWALD BARRED

The Commission entered Findings and an Order Imposing Remedial Sanctions against Bishop, Baldwin, Rewald, Dillingham & Wong, Inc. (Bishop Baldwin), a registered investment adviser formerly of Honolulu, Hawaii, and Ronald R. Rewald (Rewald), its former chairman and control person. The Order revokes Bishop Baldwin's registration as an investment adviser and bars Rewald from association with any regulated entity. These findings and sanctions were entered following the orders of default against Bishop Baldwin and Rewald after they failed to answer or appear in public administrative proceedings instituted by the Commission on August 10 under the Investment Advisers Act of 1940.

The Order finds that: Bishop Baldwin and Rewald had been previously enjoined from further violations of the antifraud provisions of the Securities Act of 1933, the Securities Exchange Act of 1934 and the Advisers Act and certain reporting provisions of the Advisers Act in their offer and sale of unregistered investments in an Investment Savings Account; Bishop Baldwin wilfully violated and Rewald wilfully aided and abetted violations of the Brochure Rule and certain reporting, bookkeeping and recordkeeping provisions of the Advisers Act; and Bishop Baldwin and Rewald wilfully violated the registration provisions of the Securities Act and the antifraud provisions of the Securities, Exchange and Advisers Acts. COMMISSION ANNOUNCEMENTS

AIA INDUSTRIES, INC.; TOWNER PETROLEUM COMPANY

> The Commission announced that on October 25 and November 26, respectively, the bankruptcy court granted the motion filed by the Commission for the appointment of an equity security holders' committee in these pending Chapter 11 reorganization cases involving large publicly held corporations. The Commission argued that the appointment of a committee under Section 1102(a)(2) of the Bankruptcy Code is necessary in order to ensure adequate representation of AIA's and Towner's shareholders. (AIA Industries, Inc., No. 84-02411, Bankr., ED PA; Towner Petroleum Company, No. 84-02184B, Bankr., WD OK). (CR-339 and CR-340)

CIVIL PROCEEDINGS

COMPLAINT NAMES KENNETH D. MORGAN

The Commission filed a complaint on December 11 in the U.S. District Court for the Southern District of New York against Kenneth D. Morgan for insider trading in violation of the antifraud provisions of the Securities Exchange Act of 1934. Simultaneously with the filing of the complaint, Morgan entered into a Consent Decree in which he consented to a Final Judgment of Permanent Injunction barring him from future violations of the antifraud provisions of the Exchange Act.

The complaint alleges that Morgan: while employed as a Vice President-Development in a division of McGraw-Hill Inc., acquired material, nonpublic information concerning McGraw Hill's acquisition of The Monchik-Weber Corporation; and illegally traded on that information by purchasing 9,000 shares of Monchik-Weber's stock one business day before the public announcement of McGraw-Hill's agreement to acquire Monchik-Weber.
