INVESTMENT COMPANY ACT RELEASES

PRINCIPAL PRESERVATION TAX-EXEMPT FUND, INC.

A notice has been issued giving interested persons until January 7, 1985 to request a hearing on an application filed by Principal Preservation Tax-Exempt Fund, Inc. for an order exempting it from the provisions of Section 22(d) of the Investment Company Act to permit sales of its shares at a reduced sales load to certain directors of its adviser's parent holding company. HOLDING COMPANY ACT RELEASES

ENSERCH GAS TRANSMISSION COMPANY

An order has been issued clarifying the Commission's order of December 4 (Rel. 35-23515) that it was ENSERCH Gas Transmission Company being declared not a *gas utility company" under Section 2(a)(4) of the Public Utility Holding Company Act of 1935. (Rel. 35-23530 - Dec. 13)

GULF POWER COMPANY

An order has been issued authorizing a proposal by Gulf Power Company, subsidiary of The Southern Company, to enter into the financing of pollution control facilities in an amount not to exceed \$42 million. (Rel. 35-23531 - Dec. 13)

THE SOUTHERN COMPANY

A supplemental order has been issued authorizing Georgia Power Company, subsidiary of The Southern Company, to effect short-term borrowings in the financing of certain pollution control facilities through the issuance by Georgia Development Authorities of their revenue bond anticipation notes.
