## LANUE COMMISSION **IVESTMENT COMPANY ACT RELEASES**

#### J.P. MORGAN ACCEPTANCE CORPORATION I

A notice has been issued giving interested persons until February 27 to request a hearing on an application filed by J.P. Morgan Acceptance Corporation I for an order conditionally exempting it and certain trusts it may form from all provisions of the Investment Company Act to permit it and the trusts to sell collateralized mortgage obligations and residual interest certificates. MISSISSIPPI POWER & LIGHT COMPANY

A supplemental order has been issued authorizing a proposal by Mississippi Power and Light Company (MP&L), and its parent company, Middle South Utilities, Inc. (MSU), whereby MP&L will issue and sell through December 31, 1989 and MSU will acquire an aggregate of up to 1,304,600 shares of MP&L's common stock, no par value, at a price of \$23 per share, for an aggregate cash consideration not to exceed \$30,005,800. #### CEDAR COAL COMPANY
