# **CIVIL PROCEEDINGS**

PERMANENT INJUNCTION ENTERED AGAINST MALCOLM B. DAVIS AND PLUS, INC.

The Commission announced that on January 25 the U.S. District Court for the Northern District of Texas entered a permanent injunction against Malcolm B. Davis and Plus, Inc., enjoining them from future violations of the antifraud and tender offer provisions of the Securities Exchange Act of 1934 and Rules 10b-5 and 14e-3. Defendants consented to the injunction without admitting or denying the allegations in the Commission's Complaint.

The January 5, 1984 Complaint alleged that W. Paul Thayer, then Deputy Secretary of Defense, had transmitted material non-public information concerning corporate developments involving several companies with which he had been associated to Billy Bob Harris, a Dallas stockbroker. Harris, in turn, was charged with transmitting that information to others, including Davis, President and Chief Operation Officer of Plus, Inc. Thayer and Harris settled the Commission's allegations and pled guilty to criminal charges of obstruction of justice in connection with the Commission's investigation in May 1985. (SEC v. W.
