## **ADMINISTRATIVE PROCEEDINGS**

PAUL H. METZINGER SANCTIONED

The Commission issued an Order Instituting Proceedings and Opinion and Order under Rule 2(e) of its Rules of Practice against Paul H. Metzinger, a Denver-based attorney. Metzinger consented to the Order which finds, among other things, that he was permanently enjoined from violating certain provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934, including the registration, antifraud, antimanipulation, issuer-reporting, issuer-accounting, securities-ownership reporting, and broker-dealer registration provisions [SEC v. Dynapac, Inc., et al., DCO, Civ. No. 87-Z-1130; SEC v. Metzinger, DCO, Civ. No. 89-7227]. The Commission denied Metzinger the privilege of appearing or practicing before it for three years, beginning 90 days from the date of the Order. (Rel. 34-26640)

## **CRIMINAL PROCEEDINGS**

J. THOMAS DOTSON SENTENCED

The U.S. Attorney for the Northern District of Georgia and the Atlanta Regional Office announced that on March 10 Judge Horace T. Ward sentenced J. Thomas Dotson to 90 days in a half-way house, five years probation, and restitution of \$354,957. Dotson had previously pled guilty to one count of securities fraud and one count of mail fraud on January 3. The plea was the result of investigations by the Commission and the U.S. Attorney's Office.

On February 8, Dotson was permanently enjoined from future violations of the antifraud provisions of the securities laws. Dotson consented to the Final Judgment without admitting or denying the allegations, in an action brought by the Commission [SEC v. J. Thomas Dotson, USDC NDGA, Civil Action No. 88-CV-256-GET, LR-11672]. (U.S. v. J. Thomas Dotson, USDC NDGA, CR-298A). (LR-12041)

GEORGE INSERRA, OTHERS PLEAD GUILTY

The New York Regional Office announced that on March 3 George Inserra, John Inserra, and John Giura entered guilty pleas in the U.S. District Court in Syracuse, New York to criminal offenses relating to a scheme to defraud the Teamster's Pension and Welfare Funds in Utica, New York.

George and John Inserra entered guilty pleas to conspiracy to commit securities fraud. Between May 1982 and May 1983, while registered representatives at Shearson Lehman Hutton Inc., in Utica, the Inserras and Giura, then a partner at Stein Roe & Farnham, purchased securities and placed them in a holding account. If the securities' value increased, they were transferred to accounts of friends, relatives or associates of the Inserras and Giura who realized profits. If the securities' value decreased, they were transferred to Teamster Funds' accounts which realized losses. George Inserra also entered guilty pleas to soliciting, receiving and attempting to receive kickbacks, and to filing a false tax return. The kickbacks were brokerage commissions from investment advisers, including Stein Roe, used by George Inserra failed to report approximately \$4,100 of income, mostly profits from the illegal securities transactions, in 1983. Giura entered pleas of guilty to one count of conspiracy to obstruct justice and perjury in connection with a Commission investigation and to one count of endeavoring to obstruct justice in connection with a grand jury proceeding in the Southern District of New York. George Inserra faces maximum penalties of five years imprisonment, fines of \$360,000, and may be required to pay restitution. John Inserra faces maximum penalties of five years imprisonment, and a \$10,000 fine. Giura faces maximum penalties of five years imprisonment and fines of \$500,000.

Sentencing is scheduled for May 19 in Syracuse, before Judge Howard G. Munson. (U.S. v. George A. Inserra, et al., NDNY, 88-CR-104; U.S. v. John Giura, NDNY, 89-CR-4; U.S. v. George A. Inserra, et al., NDNY, 89-CR-5). (LR-12042)

### INVESTMENT COMPANY ACT RELEASES

FIRST FEDERALIST FUND, INC.

An order has been issued declaring that First Federalist Fund, Inc. has ceased to be an investment company. (Rel. IC-16885 - Mar. 21)

**KEYSTONE PROVIDENT LIFE INSURANCE COMPANY** 

An order has been issued exempting Keystone Provident Life Insurance Company, KMA Variable Account, and Keystone Provident Financial Services Corp. from the provisions of Sections 2(a)(35), 26(a)(2)(C), and 27(c)(2) of the Investment Company Act to permit the deduction of an asset based sales charge and mortality and expense risk charges from the assets of the Account. ML VENTURE PARTNERS II, L.P.

An order has been issued on an application filed by ML Venture Partners II, L.P. (MLVP II), Merrill Lynch Venture Capital Inc. (the Management Company), which provides management services for MLVP II, and ML Technology Ventures, L.P. (1) granting an exemption from the provisions of Section 57(a)(1) of the Investment Company Act to permit MLVP II to acquire certain securities from the Management Company; and (2) permitting a transaction under Section 17(d) and Rule 17d-1 in which MLVP II and ML Technology will participate in a joint arrangement relating to such securities which would otherwise be prohibited under Section 57(a)(4) of the Act. CORRECTION RE BOSTON FINANCIAL QUALIFIED HOUSING TAX CREDITS L.P.

## HOLDING COMPANY ACT RELEASES

GENERAL PUBLIC UTILITIES CORPORATION

An order has been issued authorizing General Public Utilities Corporation (GPU), a registered holding company, and its subsidiary, General Portfolios Corporation (GPC), for GPU to make contributions to the capital of GPC consisting of the shares of stock of two mutual insurance companies, Exel Limited and ACE Limited, which shares GPU acquired in 1986. CENTRAL POWER AND LIGHT COMPANY

An order has been issued authorizing Central Power and Light Company (CP&L), subsidiary of Central and South West Corporation, to lease its unit trains and railcars to nonassociated companies from time to time on a short-term basis when they are not being used by CP&L. (Rel. 35-24844 - Mar. 22)

· IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

Proposed rule changes filed by the following companies have become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934: <u>The Government Securities</u> <u>Clearing Corporation</u> (SR-GSCC-89-1) to enhance its comparison system by adding a pending file that would permit data on uncompared trades to remain in the system until compared or deleted. It also would provide an "as-of" feature that will enable Members to submit trade data for comparison on or after the settlement date.
