# COMMISSION ANNOUNCEMENTS

COMMISSION RELEASES SPEECH .

The Commission today released a speech entitled, "Future Issues in Market Regulation," by Richard G. Ketchum, Director, Division of Market Regulation. It was delivered on March 22 before the Corporation, Finance and Securities Law Section of the D.C. Bar in Washington, D.C.

## **ADMINISTRATIVE PROCEEDINGS**

PROCEEDINGS INSTITUTED, SANCTIONS IMPOSED AGAINST JACK S. STATON

The Commission instituted public administrative proceedings under the Securities Exchange Act of 1934 against Jack Staton, of Naples, Florida, a former registered representative of Elliott Securities, Inc., a broker-dealer registered with the Commission.

Simultaneously, the Commission accepted Staton's Offer of Settlement. The Offer of Settlement consents to, and the Commission entered: (1) findings that Staton violated the registration and antifraud provisions of the Securities Act of 1933 and the Exchange Act; and (2) an Order suspending Staton from association with any broker, dealer, municipal securities dealer, investment adviser or investment company for 60 days. The Offer of Settlement was made without admitting or denying the findings contained in the Order. (Rel. 34-26684)

# PROCEEDINGS INSTITUTED, SANCTIONS IMPOSED AGAINST STEVEN HAMMER

The Commission instituted public administrative proceedings under the Securities Exchange Act of 1934 against Steven Hammer, of Naples, Florida, a former registered representative of Elliott Securities, Inc., a broker-dealer registered with the Commission.

Simultaneously, the Commission accepted Hammer's Offer of Settlement. The Offer of Settlement consents to, and the Commission entered: (1) findings that Hammer violated the registration and antifraud provisions of the Securities Act of 1933 and the Exchange Act; and (2) an Order suspending Hammer from association with any broker, dealer, municipal securities dealer, investment adviser or investment company for 60 days. The Offer of Settlement was made without admitting or denying the findings contained in the Order. (Rel. 34-26685)

#### PROCEEDINGS INSTITUTED AGAINST HOWARD A. RUBIN

The Commission instituted public administrative proceedings under the Securities Exchange Act of 1934 against Howard A. Rubin, the former head mortgage-backed securities trader for Merrill Lynch Government Securities, Inc.

The Order Instituting Proceedings alleges that in April 1987, Rubin violated the antifraud provisions of the federal securities laws by failing to disclose an unauthorized transaction involving \$500 million of "stripped" mortgage-backed securities. Merrill Lynch Pierce Fenner & Smith, Inc. honored the transaction, at a loss of approximately \$85 million. The Order further alleges that Rubin aided and abetted violations of the books and records provisions of the Exchange Act by Merrill Lynch.

A hearing will be scheduled to determine whether the allegations against Rubin are true, and, if so, to decide what remedial action, if any, is appropriate. (Rel. 34-26686)

### OFFER OF SETTLEMENT ACCEPTED FROM ELIA CALVELLI

In administrative proceedings ordered under Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 and Section 14(b) of the Securities Investor Protection Act of 1970, Elia Calvelli submitted an Offer of Settlement which the Commission accepted.

Calvelli, without admitting or denying the allegations, except as to the injunction mentioned below, which he admitted, consented to Commission findings that from June 1984 to about June 1986, he: (1) aided and abetted Cusack Light & Co., Inc.'s (Registrant), a registered broker-dealer, violations of various back office provisions of the Exchange Act; (2) was enjoined by a federal district court from further violations of various provisions of the securities laws; and (3) was responsible for the need of an appointment of a trustee to liquidate Registrant.

The Commission ordered that Calvelli be barred from association with any broker, dealer, investment company, investment adviser or municipal securities dealer; provided that he could reapply after three years to become associated in a nonsupervisory, nonproprietary capacity. (Rel. 34-26687)

PROCEEDINGS INSTITUTED AGAINST THE STUART-JAMES CO., INC. AND ASSOCIATED PERSONS

The Denver Regional Office announced that on March 28, 1989, the Commission entered an Order Instituting Proceedings pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 against The Stuart-James Co., Inc., a Denver, Colorado based broker-dealer. Also named in the Order were: C. James Padgett and Stuart Graff, principals of Stuart-James; two current or former regional vice presidents; and seven current or former branch office managers.

Among other things, the Order alleges that: (1) Stuart-James charged excessive mark-ups during the first day of trading of two securities it underwrote; (2) used telephone solicitation scripts which predicted percentages of return from investments; and (3) failed to supervise certain branch offices whereby certain customers, (a) were discouraged from selling securities unless another customer could be found to purchase the security, and (b) in order to purchase new issue securities in a public offering were asked to agree to either sell such securities or buy additional securities when trading started. ### HOLDING COMPANY ACT RELEASES

#### CONSOLIDATED NATURAL GAS COMPANY

A notice has been issued giving interested persons until April 28 to request a hearing on a proposal by Consoliated Natural Gas Company (CNG), a registeed holding company, to amend its Certificate of Incorporation (Charter), subject to shareholder approval, to increase the number of its authorized shares of common stock, \$2.75 par value, from 120 million shares to 200 million shares. CNG has been authorized to solicit proxies from its common stockholders for the annual meeting to be held on May 16, 1989, in connection with the proposed amendment to its Charter. (Rel. 35-24854)

### CENTRAL AND SOUTH WEST CORPORATION

An order has been issued authorizing Central and South West Corporation (CSW), a registered holding company, and its subsidiary companies, Central Power and Light Company, Public Service Company of Oklahoma, Southwestern Electric Power Company, West Texas Utilities Company, Transok, Inc. and Central and South West Services, Inc., to issue and sell, through March 31, 1991, short-term notes and commercial paper in an aggregate principal amount outstanding at any one time of up to \$600 million, subject to individual corporate limitations on such borrowings, and to acquire notes through the CSW system money pool.
