### ADMINISTRATIVE PROCEEDINGS

NASD ACTION AGAINST SHEARSON LEHMAN HUTTON AND TWO OFFICIALS AFFIRMED

> The Commission affirmed disciplinary action taken by the NASD against Shearson Lehman Hutton Inc., of New York City, Randolph G. Peyton, manager of Shearson's Washington, DC branch office, and Ronald L. Salyer, a senior vice president and registered representative in that office. The NASD censured respondents and fined them \$3,000, jointly and severally.

> The Commission found, as had the NASD, that Salyer engaged in excessive trading in a customer's discretionary account. In a 13-month period, the account was turned over 7.4 times, and the markups, commissions, and margin interest charged to the account exceeded 50% of the customer's original investment. Salyer also failed to obtain the necessary written authorizations for opening a discretionary account. The Commission also affirmed the NASD's findings that Shearson and Peyton failed to exercise proper supervision with respect to Salyer's excessive trading. (Rel. 34-26766)

## **CIVIL PROCEEDINGS**

JUDGMENT ENTERED AGAINST EDWARD R. SCHARPS

The Commission announced that on May 3 the U.S. District Court entered a Judgment against Edward R. Scharps, founder and former chief executive officer of Capt. Crab's Take-Away, Inc., a Florida-based franchisor, ordering him to disgorge \$1 million and permanently enjoining him from violating the registration and antifraud provisions of the Securities Act of 1933 and the antifraud provisions of the Securities Exchange Act of 1934. The \$1 million disgorgement sum will be placed in the custody of a receiver for distribution to investors with valid claims arising from their trading in the securities of Capt. Crab from March 1, 1982 through December 31, 1984. Scharps, who consented to the Judgment in settlement of the Commission's market-manipulation case against him, neither admits nor denies the Commission's allegations. (SEC v. Capt. #### **CRIMINAL PROCEEDINGS**

DAVID L. WILLIAMS SENTENCED

The Boston Regional Office and the New Hampshire Attorney General announced that on April 14 a Hillsborough County, New Hampshire Superior Court sentenced David L. Williams to eight to seventeen years for theft and securities law violations. In February, Williams was convicted, after a jury trial, on six counts of theft and seven counts of securities fraud in connection with his activities as a real estate developer and investment adviser.

Williams' sentence to five to ten years on the theft charges is to be served concurrently with the six year federal sentence he received on federal charges of mail and investment adviser fraud. His three to seven year state sentence on securities fraud is to be served consecutive to his federal sentence.

Williams' sentencing is the result of a three-year joint investigation by the New Hampshire Attorney General, the U.S. Attorney for the District of New Hampshire, the Fraud Section, Criminal Division of the U.S. Department of Justice, the U.S. Postal Inspection Service, and the Boston Regional Office.
