OPEN MEETING - THURSDAY, JULY 20, 1989 - 10:00 a.m.

The subject matter of the July 20 open meeting will be:

- (1) Consideration of whether to propose amendments to Rule 15c2-11, 17 CFR 240.15c2-11, under the Securities Exchange Act of 1934. The proposed amendments would require a broker-dealer commencing quotations to (a) have a copy of any trading suspension order (or the companion Commission release) respecting the security issued within the preceding 12 months, and to review the required information in its records in light of such order; and (b) obtain recent reports filed by Form 8-K by the issuer of the security. The proposed amendments also pertain to the information to be obtained regarding new reporting issuers, the period of retention of the required information, and the form to be furnished to the interdealer quotation system. - (2) Consideration of whether to issue a release proposing amendments to the New Capital Rule. Under the proposed Securities Exchange Act Rule 15c3-1 would be amended to raise the minimum net capital required of registered broker-dealers and to standardize the deductions that broker-dealers incur in arriving at net capital for their equity securities positions. Furthermore, the amendments would establish a haircut for zero coupon bonds and relieve certain aggregate indebtedness charges. FOR FURTHER INFORMATION, PLEASE CONTACT David I. A. - (3) Consideration of whether to adopt Rule 32a-3 under the Investment Company Act of 1940. CIVIL PROCEEDINGS

LEONARD J. MULLEN ENJOINED

The Boston Regional Office filed a Complaint on June 30 in the U.S. District Court for the District of Connecticut against Leonard J. Mullen, formerly the Assistant Controller - Audit with the Stamford, Connecticut based General Signal Corporation, Inc. (GSX). The Complaint alleged that Mullen, while in the course of his employment, received and recklessly misappropriated material non-public information from his employer relating to GSX's confidential negotiations to acquire the Andover, Massachusetts based GCA Corporation, Inc.

The Commission alleged that Mullen recklessly misappropriated the information for his own financial gain by purchasing GCA stock, prior to the public announcement of GSX's negotiations to acquire GCA, and selling it 12 days later at a profit of \$11,250.50. Simultaneously, Mullen, without admitting or denying the Complaint's allegations, consented to a Final Order of Permanent Injunction. The Final Order enjoins him from future violations of the antifraud provisions of the Securities Exchange Act of 1934. In addition, Mullen is ordered to pay \$11,250.50 in disgorgement, and a penalty of \$11,250.50 under the Insider Trading Sanctions Act of 1984 to the U.S. Treasury. (SEC v. Leonard J. COMPLAINT NAMES WILLIAM F. HARKAY

The Philadelphia Regional Office filed a Complaint on July 10 in the U.S. District Court for the Eastern District of Virginia against William F. Harkay. The Complaint alleges that Harkay violated the registration and antifraud provisions of the securities laws, and seeks a permanent injunction together with an accounting and disgorgement.

The Complaint charges that from 1982 to 1988, Harkay fraudulently offered and sold to more than 450 investors in 22 states at least \$11.3 million of unregistered securities in the form of short-term interest bearing promissory notes issued by The Harkay Corporation. In order to induce individuals to invest in Harkay Corporation, Harkay made material misrepresentations and omitted to disclose material facts concerning Harkay Corporation, the nature of the investment, and the use of investor funds. INVESTMENT COMPANY ACT RELEASES

SCHRODER CAPITAL FUNDS, INC.

An order has been issued granting an exemption from the provisions of Section 17(a) of the Investment Company Act to Schroder Capital Funds, Inc. (Schroder Capital), Fund Source, Schroder Capital Management International Inc., and Schroder Holdings, Inc. The requested relief will permit two newly created series of Schroder Capital to each acquire the respective assets and liabilities of one of two series of Fund Source, International Equity Trust, and Global Bond Trust, in exchange for shares of the applicable series of Schroder Capital, which shares will be distributed in liquidation to the shareholders of the applicable Fund Source series. COWEN FUNDS, INC.

An order has been issued on an application filed by Cowen Funds, Inc., Standby Reserve Fund, Inc., Standby Tax-Exempt Reserve Fund, Inc., and Cowen & Co. for an order to permit exchanges of shares of certain Cowen Funds for shares of Standby Reserve and Standby Tax-Reserve on a basis that may be at other than their respective net asset values at the time of exchange. HOLDING COMPANY ACT RELEASES

SYSTEM ENERGY RESOURCES, INC.

A supplemental order has been issued authorizing System Energy Resources, Inc., subsidiary of Entergy Corporation, to acquire its nuclear fuel by lease in amounts of up to \$250 million. (Rel. 35-24919 - July 7)

THE SOUTHERN COMPANY

An order has been issued authorizing a proposal by The Southern Company, a registered holding company, and its subsidiaries, Alabama Power Company, Georgia Power Company, Gulf Power Company, Mississippi Power Company, Southern Company Services, Inc., Southern Electric Generating Company, and Southern Electric International, Inc., for Southern to issue and sell from time-to-time through March 31, 1992, a maximum of 2,000,000 shares of its authorized but unissued common stock, par value \$5 per share (Additional Common Stock), in order to fund its system-wide employee stock ownership plan (Plan). The subsidiaries and/or the trust established under the Plan will purchase the Additional Common Stock. In addition, Southern has been authorized to acquire for its own account up to 15 million shares of its common stock presently outstanding, in negotiated or open market transactions or tender offers from time-to-time through March 31, 1992. Jurisdiction is reserved with respect to participation in the Plan by employees of Southern Nuclear Operation Company, Inc., a proposed subsidiary of Southern. (Rel. 35-24920 - July 7)
