CIVIL PROCEEDINGS

COMPLAINT NAMES STEVEN TELSEY

The New York Regional Office filed a Complaint against Steven Telsey in the Southern District of New York seeking a court order requiring compliance with a Commission consent order that permanently barred him from associating with any broker, dealer, registered investment adviser, or registered investment company. The Complaint alleges that Telsey, of Fort Lauderdale, Florida, unlawfully associated with at least five broker-dealers in violation of the Commission order [In the Matter of Steven Telsey, Release 34-10653, February 22, 1974]. The Complaint additionally seeks disgorgement of funds Telsey received during the course of the violations and pre-judgment interest.

The Complaint alleges that from June 1984 to the present, Telsey executed securities transactions through, and serviced customers of, Citiwide Securities Corp., Jerold Securities & Co., Inc., Russo Securities & Co., Inc., Versaille Capital Corp., and Steven Andrew & Co., Inc. According to the Complaint, between July 1985 and January 1986, while associated with Jerold Securities, Telsey held himself out to the public as a part owner of the firm. Telsey is currently the president and chairman of the Board of Directors of Triumph Capital, Inc., a publicly-held company based in Fort Lauderdale. (SEC v. Steven Telsey, 89 Civ. 4775, LS, SDNY, July 13, 1989). (LR-12158)
