CIVIL PROCEEDINGS

THE ROLFITE COMPANY AND STEPHEN L. READ CONSENT

The Commission today filed a Complaint in the U.S. District Court for the District of Columbia for a Final Judgment of Permanent Injunction as to The Rolfite Company, of New Orleans, Louisiana, and Stephen L. Read, its president, chairman, and majority shareholder, also of New Orleans. The Complaint charges Rolfite with failing to make and keep books, records, and accounts, which in reasonable detail accurately and fairly reflect the disposition of its assets as required by Section 13(b)(2)(A) of the Securities Exchange Act of 1934, and Read with aiding and abetting such violations.

Rolfite and Read have consented to the Judgment which would enjoin Rolfite from future violations of the recordkeeping provisions and Read from aiding and abetting violations of such provisions. (SEC v. The Rolfite Company and Stephen L. Read, USDC DC, Civil Action No. 89-2070, CRR). (LR-12172)

PERMANENT INJUNCTIONS ENTERED AGAINST HARRY SCHREIBER, OTHERS

The Atlanta Regional and Miami Branch Offices announced that on June 30 U.S. District Judge Kenneth L. Ryskamp, Southern District of Florida, entered Final Judgments of Permanent Injunction against Harry Schreiber, Florida Eastern Development and Management Corporation (FED), Atlantic Management and Consulting Corporation (AMC), Ruth Tune, and John M. Inglis. FED and AMC are Florida corporations located in West Palm Beach, Florida. Schreiber, Tune, and Inglis reside in Palm Beach County, Florida. Concurrently, defendants consented to the Final Judgments. The Final Judgments enjoin defendants from violating the registration and antifraud provisions of the securities laws and require them to file an accounting and disgorge an amount to be determined at a later date.

The Complaint alleges that defendants offered and sold approximately \$50 million of unregistered securities and made numerous misrepresentations and omissions of material facts to promote the securities concerning, among other things, Schreiber's criminal background and FED's financial condition. (SEC v. Harry Schreiber, et al., SDFL, Civil Action No. 89-8288-CIV-RYSKAMP). (LR-12170)

INVESTMENT COMPANY ACT RELEASES

PREMIER ACCEPTANCE CORPORATION

An order has been issued exempting Premier Acceptance Corporation and Piper Jaffray Incorporated from all provisions of the Investment Company Act to permit them to issue collateralized mortgage obligations and to sell residual interests in any excess cash flow on such obligations. VENTURE TRUST TAX-FREE MONEY MARKET FUND

An order has been issued declaring that Venture Trust Tax-Free Money Market Fund has ceased to be an investment company. (Rel. IC-17075 - July 20)

PAINEWEBBER EXECUTIVE INVESTMENTS FUND, L.P.

An order has been issued on an application filed by PaineWebber Executive Investments Fund, L.P. (Partnership) and NCRS Holdings Inc. for an order granting an exemption from the provisions of Section 17(a) to permit the Partnership to sell and NCRS to acquire certain securities of National Car Rental System, Inc.
