

ADMINISTRATIVE PROCEEDINGS

STEPHEN P. CLARK CENSURED AND SUSPENDED

The Commission announced today the censure and nine-month suspension of Stephen P. Clark, CPA and partner in the accounting firm of Peat, Marwick, Main & Co., from appearing and practicing before the Commission. The censure and suspension was the result of Clark's conduct in connection with the audit of The Midwestern Companies, Inc. for the fiscal year ending December 31, 1982. Clark served as the engagement partner in that audit. The Commission instituted proceedings under Rule 2(e) of its Rules of Practice against Clark on March 6, 1989.

The suspension and censure of Clark was part of a settlement which the Commission accepted in its Opinion and Order dated August 11, 1989. The Opinion and Order described the audit conduct of Clark in the 1982 audit of Midwestern. It concluded that Clark violated the due care requirement of generally accepted auditing standards by signing an unqualified opinion stating incorrectly that Midwestern's 1982 financial statements were presented in accordance with generally accepted accounting principles. CIVIL PROCEEDINGS

INJUNCTIVE ACTION FILED AGAINST PENNY STOCK PROMOTERS

The Fort Worth Regional Office filed an injunctive action on August 7 in the U.S. District Court for the Northern District of Texas against AMX International, Inc., a Dallas, Texas based reporting company, and three of its principals, William B. Clark, Frank E. Snell, and Benjamin F. Meador. Also named were Peter G. Lund, a principal of a registered broker-dealer which sold the AMX stock, and Charles E. Washburn, a certified public accountant who certified AMX's financial statements. The Complaint charges defendants with violating, or aiding and abetting violations of various registration, antifraud, reporting, books and records, and proxy provisions of the securities laws. The charges stem from an alleged scheme to merge a private company having assets of questionable value with a public "shell" company; and then to manipulate the company's stock prices. The action seeks permanent injunctive relief, among other remedies. (SEC v. AMX International, Inc., et al., USDC NDTX, Dallas Division, Civil Action No. CA 3-89-2006-H). (LR-12213)

CRIMINAL PROCEEDINGS

WALTER R. MOONEY, OTHERS SENTENCED FOR CONTEMPT

The Fort Worth Regional Office announced that on August 3 U.S. District Judge Robert B. Maloney, Northern District of Texas, imposed jail sentences on Walter R. Mooney, George R. Carter, and Douglas Litchfield of six months, five months, and 120 days, respectively, for criminal contempt. The criminal contempt action, which the Commission was appointed to prosecute, arose out of a civil injunctive action styled <u>SEC v.</u> Oreo Mines, Inc., et al., a precious metals investment contract, or "dirt-pile," scam.

Judge Maloney found Carter, an attorney, Litchfield, a defendant in the civil action, and Mooney had violated the Court's previous injunction by filing involuntary bankruptcy petitions against two corporations the Judge had placed in receivership. Testimony introduced during the contempt hearing established, among other things, that certain of the creditors on whose behalf the bankruptcy petitions were purportedly filed, had not authorized the filings. (U.S. ex rel SEC v. George Carter, et al., CR 3-89-036-T). (LR-12212)

INVESTMENT COMPANY ACT RELEASES

SECURITY FIRST LIFE INSURANCE COMPANY

A notice has been issued giving interested persons until September 4 to request a hearing on an application filed by Security First Life Insurance Company, Security First Life Separate Account A, and Security First Financial, Inc. for an order exempting from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Investment Company Act to permit the deduction of mortality and expense risk charges in connection with the issuance of certain group annuity contracts issued by the Capitol Life Insurance Company and proposed to be reinsured by Security First Life Insurance Company. HOLDING COMPANY ACT RELEASES

ELECTEC, INC.

A supplemental order has been issued authorizing Electec, Inc., subsidiary of Entergy, Inc., to enter into an agreement, through December 31, 1989, with an initial eightyear term, with the Vosko Arkansas Joint Venture, pursuant to which Electec will assign to the Joint Venture rights to process liquid hydrocarbons contained in a natural gas stream owned by Arkansas Power & Light Company, subsidiary of Entergy. NOTICE OF PROPOSED RULE CHANGES

A proposed rule change has been filed under Rule 19b-4 by: <u>The National Association</u> of <u>Securities Dealers</u> (SR-NASD-89-26) that would allow it to provide required information to its members via the Notice to Members mechanism, have the members distribute pertinent information to the appropriate parties within the firm, and to require members to maintain a copy of the NASD manual in every branch office. (Rel. 34-27105); and <u>The Philadelphia Stock Exchange</u> (SR-Phix-89-25) to permit it to allocate new equity books or option classes without providing floor members with five days advanced notice of the security to be allocated and its applicants.
