CIVIL PROCEEDINGS

EXCHANGE COMMISSION

PERMANENT INJUNCTION ENTERED AGAINST DONALD L. BRADY

The Atlanta Regional and Miami Branch Offices announced that on July 26 U.S. District Judge Kenneth L. Ryskamp, Southern District of Florida, entered a Final Judgment of Permanent Injunction against Donald L. Brady of West Palm Beach, Florida. Brady was an officer of Florida Eastern Development and Management Corporation (FED), a Florida corporation which syndicated real estate limited partnerships. The Final Judgment enjoins Brady from violating the registration and antifraud provisions of the securities laws, and requires an accounting and disgorgement by Brady in an amount to be determined later. Brady consented to the Final Judgment without admitting or denying the allegations in the Commission's Complaint.

The Complaint alleges that Brady and others sold approximately \$50 million in unregistered securities, and made numerous misrepresentations and omissions of material facts to promote the securities concerning, among other things, the criminal background and bankruptcy of the promoter, the use of investors' proceeds, and the financial condition of FED. (SEC v. Harry Schreiber, et al., SDFL, Civil Action No. 89-8288-CIV-RYSKAMP). (LR-12216)

INVESTMENT COMPANY ACT RELEASES

AMA INCOME FUND, INC.

An order has been issued (1) granting an exemption from the provisions of Section 17(A) of the Investment Company Act to permit certain transactions by which the AMA Income Fund, Inc. (the AINC Funds) will acquire all of the assets, subject to the liabilities, of certain affiliated funds (the AMA Group Funds), in exchange for shares of common stock of new series of the AINC Funds which will then be distributed to shareholders of the AMA Group Funds; and (2) permitting the sharing of certain expenses of the proposed reorganization by the AINC Funds and the AMA Group Funds. HOLDING COMPANY ACT RELEASES
