# **COMMISSION ANNOUNCEMENTS**

CHAIRMAN RUDER SPEAKS IN VENICE, ITALY

The Commission released, "Cooperative International Securities Regulation," a speech being given by David S. Ruder, Chairman, in Venice, Italy today. Chairman Ruder is representing the Commission at the 14th Annual Conference of the International Organization of Securities Commissions (IOSCO). In his speech, he revisits the Policy Statement on Regulation of International Securities Markets (November 1988) presented by the Commission at the last IOSCO meeting, reviews progress made to date by international regulators in promoting a coordinated approach to securities regulation, and reports on some recent SEC initiatives.

### CIVIL PROCEEDINGS

DISGORGEMENT ORDERS ENTERED AGAINST COELCO, LTD. AND DAVID D. STERNS

The Los Angeles Regional Office announced that on August 31 the U.S. District Court for the Central District of California issued orders of disgorgement against CoElco, Ltd. and David D. Sterns. The orders require CoElco and Sterns to disgorge all proceeds received by them from the fraudulent offers, purchases, and sales of CoElco securities alleged in the Complaint, with payment of disgorgement and prejudgment interest waived on condition that sworn representation of CoElco and Sterns concerning their financial inabilities to pay disgorgement are true, accurate, and complete. CoElco and Sterns consented to disgorgement orders, without admitting or denying the Complaint's allegations of wrongdoing. CoElco and Sterns previously consented to orders of permanent injunction variously enjoining them from violations of the registration, antifraud, issuer reporting, proxy solicitation, and securities ownership reporting provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934. # **INVESTMENT COMPANY ACT RELEASES**

### UNLISTED TRADING SOUGHT

#### COMMENT PERIOD EXTENDED

The Commission extended until October 2 the time for the submission of comments on amendments to the clearing agency registration application of the Clearing Corporation for Options and Securities. (Rel. 34-27242)

### APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by The American Stock Exchange (SR-Amex-89-15) to expand the "Admission of Members" section of its rules to cover the admission of options principal members, limited trading permit holders, and regular member organizations; and to require posting of prospective member organizations, allied members, and approved persons. ### TRUST INDENTURE ACT RELEASES

### 3 BEALLS HOLDING CORPORATION

A notice has been issued giving interested persons until October 9 to request a hearing on an application by 3 Bealls Holding Corporation, a Delaware corporation, under Section 310(b)(1)(ii) of the Trust Indenture Act of 1939. The application declares that the trusteeship of First Interstate Trust Company of New York under two Company indentures, and of Bankers Trust Company, under two Company indentures, is not so likely to involve a material conflict of interest as to make it necessary in the public interest or for the protection of investors to disqualify First Interstate or Bankers Trust from acting as trustee under their respective indentures.
