CIVIL PROCEEDINGS

COMPLAINT NAMES MARC STUART WEINER

The New York Regional Office filed a civil injunctive action on September 29 in federal court in Manhattan against Marc Stuart Weiner seeking a permanent injunction and disgorgement, arising from his violations of the antifraud provisions of the securities laws. The Complaint alleges that from April 1986 to August 1987 Weiner, from New York, New York, and a registered representative formerly associated with Merrill Lynch, Pierce, Fenner & Smith, Inc., misappropriated approximately \$500,000 from 15 of his customers, who had given Weiner the money to invest in various securities. The litigation is pending. (SEC v. Marc Stuart Weiner, 89 Civ. 6498, KTD, SDNY, September 29, 1989). (LR-12261)

SUMMARY JUDGMENT ENTERED AGAINST SENTRA SECURITIES CORPORATION

On September 26, the U.S. District Court for the Southern District of New York entered summary judgment against Sentra Securities Corporation requiring that it disgorge funds it obtained from two of its customers. The Commission brought its action against Sentra's customers, Frederick and Richard Strasburg, alleging that they violated the antifraud provisions of the Securities Exchange Act of 1934 and Rule 10b-5 by trading in the securities of Beneficial Corporation while in possession of material non-public information provided by their sister, Ann Stephenson, formerly an officer of Beneficial. Sentra appropriated the profits from the trades after the Strasburgs instructed Sentra to reverse the transactions. Because Sentra refused to relinquish those profits, the Commission named Sentra as a defendant to compel Sentra to disgorge the profits. Stephenson and the Strasburgs previously consented to a Final Judgment enjoining them from violating the antifraud provisions in the future. (SEC v. Ann Stephenson, et al., SDNY, 88 Civ. 3033, JES). INVESTMENT COMPANY ACT RELEASES

ALLIED CAPITAL CORPORATION

An order has been issued, on a prospective basis, permitting certain joint transactions relating to a proposed co-investment program involving Allied Capital Corporation, Allied Capital II, and the Venture Partnerships which would otherwise be prohibited by Sections 17(d) and 57(a)(4) of the Investment Company Act. (Rel. IC-17155 - Sept. 26)

GOLDEN AMERICAN LIFE INSURANCE COMPANY

An order has been issued exempting Golden American Life Insurance Company, Golden American Knox Funds Separate Account B of Golden American Life Insurance Company, and Directed Services, Inc. from the provisions of Sections 26(a)(2)(C) and 27(C)(2) of the Investment Company Act to permit the deduction of a mortality and expense risk charge from the assets of the Account under a deferred variable annuity contract and an immediate variable annuity certain contract and to permit the deduction of guaranteed death benefit charge from the accumulation value in the Account under the deferred variable annuity contract. (Rel. IC-17156 - Sept. 27)

HOLDING COMPANY ACT RELEASES

SYSTEM FUELS, INC.

An order has been issued authorizing a proposal by System Fuels, Inc. (SFI), a fuel procurement company, and its parent companies, Louisiana Power & Light Company (LP&L) and Arkansas Power & Light Company (AP&L), each a subsidiary of Entergy Corporation, and by System Energy Resources, Inc. (SERI), also a subsidiary of Entergy. SFI has been authorized to borrow an aggregate principal amount of up to \$45 million at any one time outstanding under a Revolving Credit Agreement with a bank or banks which will be granted a security interest in, among other things, SFI's nuclear materials and services inventory financed under the Credit Agreement and accounts receivable for such inventory. SFI, LP&L, AP&L, SERI, and the Banks have also been authorized to enter into a Consent and Agreement acknowledging and consenting to the security interest granted to the Banks in SFI's accounts receivable. ALLTEL CORPORATION

A notice of and order for hearing has been issued with respect to an application filed by ALLTEL Corporation for exemption of ALLTEL and its subsidiaries from the provisions of the Public Utility Holding Company Act of 1935 in accordance with Section 3(a)(3) thereof. Interested persons have been given until October 30, 1989 to file an application to participate. (Rel. 35-24959 - Sept. 28)
