COMMISSION ANNOUNCEMENTS

CORRECTION RE FOIA APPEAL OF PAUL J. DEZENBERG

Due to a typographical error, the announcement in the October 5th News Digest regarding the FOIA appeal of Paul J. Dezenberg incorrectly stated that the General Counsel determined that documents responsive to Dezenberg's FOIA request "may be withheld under Exemption 7(A), 5 USC 552(b)(7)(A), and the Commission's rule implementing that exemption, 17 CFR 200.80(b)(7)." The announcement should have stated that the General Counsel determined that the documents may not be withheld under Exemption 7(A), 5 USC 552(b)(7)(A), and the Commission's rule implementing that exemption, 17 CFR 200.80(b)(7).

CIVIL PROCEEDINGS

COMPLAINT FILED AGAINST R W TECHNOLOGY, INC., OTHERS

The Boston Regional Office filed a Complaint on October 3 seeking injunctive and other relief from R W Technology, Inc., Simone V. Palazzolo, and John M. Minicucci, II. The Complaint alleges that defendants committed fraud in the unregistered distribution of RW's common stock from January 1, 1987 to the present. In promoting this offering, defendants allegedly misled investors regarding RW's actual operations, future prospects, products, customer base, and the profitability of RW's stock.

Simultaneously, and without admitting or denying its allegations, RW and Minicucci consented to the Order of Permanent Injunction and Other Relief enjoining them from further violations of the securities laws. RW also consented to provide an accounting of all funds received from investors and to offer restitution to its shareholders. (SEC v. R W Technology, Inc., No. N-89-486-WWE). (LR-12271)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The proposal (SR-NYSE-89-27) sets an examination administration fee of \$200 for the Compliance Official Qualification (Series 14) Examination. (Rel. 34-27338)

NOTICE OF PROPOSED RULE CHANGE

The Pacific Stock Exchange filed a proposed rule change under Rule 19b-4 (SR-PSE-89-23) to amend its Certificate of Incorporation and rules of the Board of Governors to exempt PSE Governors, committee members, and employees from monetary damages for breach of their fiduciary duty to the Exchange or its members, provided that such monetary liability is not the result of a violation of securities laws. Publication of the proposal is expected to be made in the Federal Register during the week of October 9. (Rel. 34-27339)
