

## **CIVIL PROCEEDINGS**

CHARLES MARION BUCHANAN AND CAYMAN INDEPENDENT PETROLEUM COMPANY ENJOINED

The Commission announced that on February 5 the Honorable S. Hugh Dillin, U.S. District Court Judge for the Southern District of Indiana, permanently enjoined Marion Charles Buchanan and Cayman Independent Petroleum Company (CIPCO) from violations of the stock registration provisions of Section 5 of the Securities Act of 1933 and the antifraud provisions of Section 17(a) of the Securities Act and Section 10(b) of the Securities Exchange Act of 1934. The injunction also requires Buchanan and CIPCO to make an accounting of their purchases and sales of Kokomo National Life Insurance Company until all other claims are satisfied in full and to indemnify the Indiana Commissioner of Insurance and the Indiana Health and Life Insurance Guaranty Association for any claims arising from the defendants' transactions. COMMISSION SUBMITS AMICUS CURIAE MEMORANDUM

The Office of the General Counsel announced that the Commission submitted a memorandum as amicus curiae to the U.S. Court of Appeals for the Second Circuit stating the Commission's position that the transfer of a controlling stock interest, or a 100 percent stock interest, in a business constitutes the sale of a "security." The Commission expressed the view that the district court's decision -- which held that the plaintiffs, who had acquired 100 percent of the outstanding stock of a business, had not purchased securities -- deprived purchasers of common stock of the protection of the securities laws contrary to the language and intent of those statutes. The Commission further urged that the district court erred in utilizing the investment contract test to determine whether common stock falls within the ambit of the federal securities laws.
