ADMINISTRATIVE PROCEEDINGS

GARY GROVER COCHRAN BARRED

The Denver Regional Office announced that the Commission, in an administrative proceeding which had been instituted by Order of the Commission on November 19, 1981, accepted an Offer of Settlement submitted by Gary Grover Cochran of Provo, Utah. In the Offer of Settlement, Cochran neither admitted nor denied the allegations made by the staff.

Based on the Order for Proceedings and Offer of Settlement, the Commission found that Cochran had wilfully violated sections of the Investment Advisers Act of 1940 and Commission rules relating to registration and advertising of investment advisers. The Commission ordered that Cochran's application for registration as an investment adviser be denied and that he be barred from registration as an investment adviser and from being associated with an investment adviser and also being associated with a broker-dealer; however, after one year, Cochran may make application to be associated as an employee of a broker-dealer on a showing of proper supervision.
