## ADMINISTRATIVE PROCEEDINGS

U.S. SECURITIES AND EXCHANCE COMMISSION

PUBLIC ADMINISTRATIVE PROCEEDINGS ORDERED AGAINST TERRY P. MCKENNA

> Public administrative proceedings have been ordered under the Securities Exchange Act of 1934 against Terry P. McKenna of Atlanta, Georgia. The proceedings are based on allegations that McKenna failed to comply in material respects with provisions under the Exchange Act governing the reporting of the acquisition of securi-ties in that no such report was filed by or on behalf of McKenna with respect to securities of Maryland Old Line Corporation, an insurance holding company with securities registered under the Exchange Act.

A hearing will be scheduled to determine whether the allegations are true, to afford McKenna an opportunity to establish any defenses and to enable the Commission to determine whether to publish findings and issue an order requiring McKenna to comply with the reporting provisions of the Exchange Act upon such terms and conditions as the Commission may specify.
