# ADMINISTRATIVE PROCEEDINGS

U.S. SECURITIES AND EXCHANCE COMMISSION

BACHE HALSEY STUART SHIELDS, INC. SANCTIONED

The Commission announced that it has instituted public administrative proceedings and simultaneously accepted an Offer of Settlement from Bache Halsey Stuart Shields, Inc. of New York, New York. The Commission found that Bache failed reasonably to supervise its registered representative with a view to preventing the representative's willful violations of Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder. The registered representative was previously sanctioned in public administrative proceeding No. 3-6105 [Rel. 34-18570] instituted by the Commission on March 17, 1982.

The Commission censured Bache, and ordered it to fully comply with its undertakings which would strengthen its procedures for verifying customer account information and for notifying customers of their account activity.

Bache consented to the above findings and sanctions without admitting or denying the allegations or findings in the Order for Proceedings. (Rel. 34-18796)

# INVESTMENT COMPANY ACT RELEASES

HUTTON GOVERNMENT FUND, INC.

# HOLDING COMPANY ACT RELEASES

THE COLUMBIA GAS SYSTEM, INC.

## SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved, on an accelerated basis, a proposed rule change filed by the Municipal Securities Rulemaking Board (SR-MSRB-82-4) to amend MSRB Rule A-3 to permit a public member of the MSRB to succeed himself in office if his first term of office was less than 18 months. #### NOTICE OF EFFECTIVENESS OF PROPOSED RULE CHANGE

A rule change filed by the Options Clearing Corporation, pursuant to Rule 19b-4, (SR-OCC-82-10) has become effective in accordance with Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The rule change provides that letters of credit which are deposited by clearing members with OCC to satisfy margin requirements shall expire no earlier than 2:00 p.m. Central Time on the September 1 following issuance. Previously, letters of credit expired at 2:00 p.m. Central Time on either the March 1 or September 1 following issuance. Publication of the proposal is expected to be made in the <u>Federal Register</u> during the week of June 21. (Rel. 34-18822)
