CIVIL PROCEEDINGS

U.S. SECURITIES AND EXCHANCE COMMISSION

JOHN H. TURNER ENJOINED; OTHER RELIEF ORDERED

The Washington Regional Office announced that on June 30 the U.S. District Court for the Western District of Pennsylvania entered a Temporary Restraining Order with the consent of defendant (1) temporarily restraining John H. Turner of Greenville, Pennsylvania, from further violations of the registration and antifraud provisions of the securities laws in connection with the offer, purchase and sale of securities, (2) freezing the assets and property of the defendant, except for ordinary living expenses, and (3) ordering an accounting of all investor funds. The Commission's complaint alleged violations of these provisions of the securities laws in connection with the offer and sale of over \$861,000 of fractional interests in non-existent certificates of deposit sold to over 56 investors. The complaint further alleges that the defendant made untrue statements of material fact and failed to state material facts including that the defendant had not purchased the certificates of deposit, had converted investor funds to his own benefit and use and falsely claimed that the investments were tax-free and guaranteed by the Federal Deposit Insurance Corporation. On July 2 the Court entered a Final Judgment and Order permanently enjoining the defendant from further violations of the above-mentioned securities laws and also entered an Order Freezing the defendant's assets and ordering an accounting. The defendant consented to these orders without admitting or denying the allegations of the complaint, (SEC v. John H. Turner, W.D. Pa., Civil Action No. 82-1251). (LR-9720)

INVESTMENT COMPANY ACT RELEASES

TAX-EXEMPT MONEY MARKET FUND, INC.

An order has been issued pursuant to Section 6(c) of the Investment Company Act of 1940 on an application of Tax-Exempt Money Market Fund, Inc. (Applicant), regis-tered under the Investment Company Act of 1940 as an open-end, diversified, management investment company, exempting Applicant to the extent necessary (1) from the provisions of Section 2(a) (41) of the Act and Rules 2a-4 and 22c-1 thereunder to permit Applicant (a) to use the amortized cost method to value its assets, (b) to consider maturity of variable rate term and demand notes and loan participation in its portfolio as the longer of the notice period required before Applicant would be entitled to prepayment on the note or the period remaining until the note's next interest rate adjustment, and (c) to value rights acquired from brokers, dealers, or banks to sell portfolio securities to such persons in the special manner described in the application; and (2) from the provisions of Section 12(d) (3) of the Act to permit Applicant to acquire rights to sell its portfolio securities to brokers or dealers. PROPERTY MORTGAGE CO. SEQUOIA FUND, INC.

An order has been issued on an application filed by Property Mortgage Co. Sequoia Fund, Inc. (Applicant) organized as an open-end, management investment company, pursuant to Section 8(f) of the Investment Company Act of 1940 declaring that Applicant has ceased to be an investment company. (Rel. IC-12553 - July 22)

NATIONAL BANK OF DETROIT, CANADA

A notice has been issued giving interested persons until August 17 to request a hearing on an application filed by National Bank of Detroit, Canada (Applicant), a Canadian commercial bank whose principal office is in Toronto, Canada. The application requests that the Commission issue an order pursuant to Section 6(c) of the Investment Company Act of 1940 exempting Applicant from all provisions of the Act so that Applicant may make a public offering of commercial paper in the United States. HOLDING COMPANY ACT RELEASES

SYSTEM FUELS, INC.

An order has been issued authorizing Arkansas Power & Light Company, Louisiana Power & Light Company, Mississippi Power & Light Company, and New Orleans Public Service Inc., subsidiaries of Middle South Utilities, Inc., and System Fuels, Inc. (SFI), subsidiary of the subsidiaries, to extend to July 31, 1983 the term of a Loan Agreement with Clipper Oil Corporation and to extend the authority of SFI and the subsidiaries to borrow during that period pursuant to the Loan Agreement in order to finance fuel oil inventory. Authorization has also been granted for additional 12-month extensions of the Loan Agreement without further authorization in the event the Loan Agreement is not amended to provide for a three year renewal period which will be the subject of a separate filing. CONSOLIDATED NATURAL GAS COMPANY

An order has been issued authorizing Consolidated Natural Gas Company, a registered holding company, to acquire from time to time through May 31, 1983, and for CNG Energy Company, a new corporation organized by Consolidated, to issue to Consolidated up to an aggregate of 21,000 shares of common stock of CNG Energy for a cash consideration of \$100 per share, up to an aggregate of \$2,100,000. CNG Energy would apply \$1,800,000 of the proceeds for feasibility studies, payment of bills and other study and internal operating costs. The balance of the proceeds would be applied to CNG Energy's Natural Gas Vehicle Division which would engage in the distribution, installation, servicing and financing of dual fuel conversion equipment for short-haul automotive fleets and fueling stations.
