ADMINISTRATIVE PROCEEDINGS

STEVEN K. KUNA, JR. SANCTIONED AND STEVE KUNA AND ASSOCIATES ORDERED TO FILE WITHDRAWAL FROM REGISTRATION

The Commission announced that Steven K. Kuna, Jr. (Kuna) of Chicago, Illinois and Wyoming, Michigan was barred from being associated with any broker, dealer, municipal securities dealer, investment company or investment adviser, provided that after five years he may apply to become re-associated in a supervised capacity upon a prior showing that he will be properly supervised, and his registration as a broker-dealer was revoked; and Steve Kuna and Associates (Associates), a Michigan limited partnership, was ordered to forthwith file a Notice of Withdrawal from Registration as a Broker-Dealer (Form BDW) which shall become effective upon filing. The Commission instituted public administrative proceedings against Kuna and Associates on July 14, 1982. Kuna is a general partner of Associates. Kuna and Associates were formerly engaged in business on the Chicago Board Options Exchange (CBOE) as market makers.

Kuna consented, without admitting or denying the allegations, in the Commission's Order for Public Proceedings, to the sanctions imposed against him and to findings by the Commission that during the period from in or about July 1979 through December 1980, he wilfully violated and wilfully aided and abetted violations of the antifraud provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934 and the rules thereunder; and during the period from on or about February 13, 1980, February 11, 1981, and December 18, 1980, respectively, to the date of the Order for Public Proceedings, he wilfully violated the broker-dealer registration provisions; the recordkeeping provisions, and aided and abetted violations by Associates of the broker-dealer registration provisions; and the recordkeeping provisions of the Exchange Act and certain rules thereunder. Associates also consented, without admitting or denying the allegations in the Commission's Order for Public Proceedings, to file forthwith a Form BDW. (Rel. 34-19256)

TRADING SUSPENSIONS

TRADING SUSPENDED IN GOLDMARK MINING CO., OTHERS

The Commission announced the single ten-day suspension of exchange and over-the-counter trading for the period beginning at 10:30 a.m. on December 1 and terminating at midnight on December 10, of the securities of Goldmark Mining Co. (formerly Stringham Minerals Corp.), a Colorado corporation located in Denver, Colorado; Commercial Gold & Silver Corp., a Utah corporation located in Salt Lake City, Utah;

Tatum Industries, Inc. (formerly Yankee Burger, Inc.); Woodward Oil, Inc.; Surety Resources Ltd. (formerly Chatham Petroleum Corp.); and Venture West Properties, all Colorado corporations located in Denver, Colorado.

The Commission suspended trading in the securities of the above companies because of questions concerning the reliability of quotations being made with respect to certain of those securities and because of questions concerning the adequacy and accuracy of information being disseminated concerning the prospective business operations and financial condition of each of the aforementioned issuers.

CIVIL PROCEEDINGS

CAYMAN ISLAND REINSURANCE CORORATION, LTD. ENJOINED

The New York Regional Office announced that on November 30 Cayman Island Reinsurance Corporation, Ltd. (Cayman Re), consented, without admitting or denying the allegations contained in the Commission's complaint, to the entry of a Final Judgment of Permament Injunction, enjoining it from further violations of the securities laws in the offer and sale or in connection with the purchase or sale of the securities of Cayman Re and any other security. Cayman Re has also filed a Consent and Undertaking by which it agrees to institute and maintain investment guidelines reasonably designed to ensure that its funds will be invested in a manner consistent with that disclosed to the company's shareholders. William E. Thompson submitted a Consent Undertaking and Final Order by Consent by which he, as an officer and director of the company, agrees to abide by the provisions of the Consent and Undertaking and Final Judgment of Permanent Injunction by Consent filed by Cayman Re. He also agrees not to engage in any acts or practices which would constitute further violations of the securities laws in the offer and sale, or in connection with the purchase or sale of the securities of Cayman Re and any other security. Paul V. Miller has consented, without admitting or denying the allegations contained in the Commission's complaint, to a Final Judgment of Permament Injunction enjoining him from further violations of the securities laws in the offer and sale, or in connection with the purchase or sale of the securities of Cayman Re and any other security. AMERICAN ELECTRIC POWER COMPANY, INC.
