## CIVIL PROCEEDINGS

COMPLAINT FOR INSIDER TRADING AND CORPORATE DISCLOSURE FRAUD; JACK ERLANGER CONSENTS

The New York Regional Office filed a complaint on January 9 in the U.S. District Court for the Southern District of New York to enjoin Ronald Hengen, Jack Erlanger, Howard Harlow, Samuel Rubenstein and Andrew Rosen from future violations of the securities laws.

The complaint alleges that: (1) between September 6 and October 5, 1983, Hengen, while performing public relations services for Puritan Pashions Corporation, received material, non-public financial information which he directly and indirectly tipped to Erlanger and Harlow, two brokers, who then traded and caused trades in Puritan stock; (2) Rubenstein and Rosen issued a false and misleading shareholder letter around September 22, 1983; (3) between September 1 and October 5, 1983, Rubenstein, as cotrustee of Puritan's Pension Trust Fund and while aware of Puritan adverse financial condition, caused the Trust Fund to sell Puritan stock; and (4) Rubenstein and Rosen failed to disclose material information rendering an outstanding public financial projection misleading.

Simultaneously with the filing of the complaint, Erlanger, without admitting or denying the complaint's allegations, consented to an injunction and payment of \$50,000. The civil injunctive action is pending against the remaining defendants. (SEC v. Ronald Hengen, et al., 86 Civ. 306 [MP], SDNY). (LR-10981)
