ADMINISTRATIVE PROCEEDINGS

TWO PROCEEDINGS INSTITUTED AGAINST MICHAEL R. MAURY AND THOMAS C. RUNGE

The Commission instituted two administrative proceedings under Section 15(c)(4) of the Securities Exchange Act of 1934 against Michael R. Maury and Thomas Runge, former Controller and Treasurer of Oak Industries, Inc. Simultaneously, the Commission accepted their Offers of Settlement in which they consented to Orders without admitting or denying the facts, findings or conclusions set forth therein.

The Order as to Maury states that he, among other things, failed to take adequate steps to cause Oak to establish adequate reserves and to disclose the effect of certain improper reserve reversals. Accordingly, the Commission found that Maury was a cause of Oak's violations of the periodic reporting provisions of the Exchange Act and also violated Exchange Act Rule 13b2-2(b).

The Order as to Runge states that based on the information available to him, he failed to take adequate steps to prevent Oak from failing to comply with proxy solicitation provisions of the Exchange Act in connection with his calculation of the remuneration provided by Oak to its CEO. NYSE DIRECTED TO BAR DANIEL I. DRAKE

The Commission issued an order directing the New York Stock Exchange, Inc. to bar Daniel I. Drake, a person subject to a statutory disqualification as a result of his criminal conviction for mail fraud, false claims against the United States and passport fraud, from becoming associated with a NYSE member firm that had proposed to employ him. The NYSE had given the Commission notice that it proposed to permit Drake to become associated with its member firm unless directed otherwise by the Commission. (Rel. 34-23025)

CIVIL PROCEEDINGS

INJUNCTIVE ACTION FILED AGAINST EVERITT A. CARTER, OTHERS

The Commission filed an action for Injunction and Other Equitable Relief on March 27 in the U.S. District Court for the District of Columbia against Everitt A. Carter, Frank A. Astrologes and Raymond W. Peirce, former directors and officers of Oak Industries, Inc. The defendants consented to the Final Judgments without admitting or denying the allegations in the Commission's complaint.

The complaint alleged that: (1) the defendants violated the antifraud and periodic reporting provisions of the Securities Exchange Act of 1934; (2) Carter and Astrologes knew or were reckless in not knowing that Oak's financial statements for the first three quarters of 1982 were materially false and misleading; (3) the defendants knew or were reckless in not knowing that the financial statements for the year ended December 31, 1982 were materially false and misleading; (4) Carter and Peirce caused Oak to issue materially false and misleading statements to the press and others concerning Oak's financial condition; (5) Carter violated the proxy solicitation provisions of the Exchange Act; and (6) Astrologes violated Exchange Act Rule 13b2-2 by omitting to state material facts to Oak's auditors. (SEC v. Everitt A. Carter, et al., USDC DC, Civil Action No. 86-0823). (LR-11040; AAER-94)

AIR VERMONT PRINCIPALS ENJOINED

The New York Regional Office announced that on March 14 Judge Robert J. Ward, U.S. District Court for the Southern District of New York, entered a Final Judgment of Permanent Injunction against Gene Kazlow, chief executive officer, and John Porter, president of North Atlantic Airlines, Inc., the Vermont-based parent of Air Vermont. The Judgment enjoins Kazlow and Porter from violating the antifraud provisions and from aiding and abetting violations of the periodic reporting provisions of the securities laws. The defendants consented to the Judgment without admitting or denying the allegations in the complaint.

The complaint alleges that between July and September 1983, Kazlow, Porter and others distributed a false and misleading prospectus during a \$2 million public offering of North Atlantic securities. Specifically, the complaint alleges that the prospectus contained misrepresentations and omissions of material facts concerning, among other things, the intended use of proceeds from the offering and the financial condition of the company. The complaint further alleges that ;North Atlantic, aided and abetted by Kazlow and Porter, failed to file certain guarterly, annual and other reports with the Commission. The action is continuing against the remaining defendants. (SEC v. North Atlantic Airlines, Inc., et al., 86 Civ. 442, KTD). (LR-11036)

GUARANTEED MORTGAGE CORPORATION III

A notice has been issued giving interested persons until April 16 to request a hearing on an application filed by Guaranteed Mortgage Corporation III (formerly Guaranteed Mortgage Corporation I) for an order exempting it from all provisions of the Investment Company Act. (Rel. IC-15012 - March 25)

ALLIED CAPITAL CORPORATION

An order has been issued authorizing certain joint transactions by Allied Capital Corporation, Allied Advisory, Inc., Allied Management Parters, Allied Venture Partnership, and certain other affiliates. (Rel. IC-15013 - March 25)

An order has been issued exempting Pactel Capital Resources, subsidiary of Pactel Telesis Group, from all provisions of the Investment Company Act. (Rel. IC-15014 - March 25)
