### CIVIL PROCEEDINGS

CIVIL ACTION FILED AGAINST JACK R. MORRIS, OTHERS

The Atlanta Regional Office filed a civil action on March 10 seeking to enjoin Jack R. Morris, Jack R. Morris & Associates, Inc. (JMA) and William A. Prior from violating the antifraud provisions of the securities laws and seeking disgorgement. The complaint alleged that the defendants purchased common stock of First Colony Savings & Loan Association, Inc. while in possession of material nonpublic information.

On March 26, a Final Judgment of Permanent Injunction was entered against Morris and JMA following their consents in which they neither admitted nor denied the allegations of the Commission's complaint and in which they consented to disgorgement of \$3,069 and \$18,608, respectively. (LR-11050)

### **INVESTMENT COMPANY ACT RELEASES**

HUTTON ADVANTAGED PROPERTIES II LIMITED PARTNERSHIP

An order has been issued on an application filed by Hutton Advantaged Properties II Limited Partnership and its general partners, Related Advantaged Residential Associates Inc., Hutton Advantaged Housing Associates Inc., and Related and Hutton Associates Limited Partnership, exempting the Partnership from all provisions of the Investment Company Act. ### **SELF-REGULATORY ORGANIZATIONS**

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the National Association of Securities Dealers, Inc. (SR-NASD-86-6) to amend the "Filing Requirements" section of the Interpretation of the Board of Governors - Review of Corporate Financing, Article III, Section 1 of the Rules of Fair Practice. The proposed rule change will exempt mortgage pass-through securities that have an investment grade rating from the filing requirement. In addition, the rule change alters the number of copies of documents, such as registration statements, underwriting agreements and pre- and post-effective amendments that must be filed by NASD members. IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

The Depository Trust Company filed a proposed rule change (SR-DTC-86-2) which became effective upon filing under Section 19(b)(3)(A). The rule change revises DTC's settlement procedures respecting certain inter-depository reclamations. (Rel. 34-23095)
