ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST CARL WRIGHT AND LEWIS HERMAN

The Commission issued an Order Instituting Proceedings and Opinion and Order Imposing Remedial Sanctions in administrative proceedings under Rule 2(e) of the Commission's Rules of Practice against Carl Wright and Lewis Herman, certified public accountants and partners in a regional certified public accounting firm in Independence, Missouri. The Opinion and Order permanently denies Wright and Herman the privilege of appearing or practicing before the Commission. They are permitted to apply to resume such appearance or practice after three years provided that certain requirements are met including that their work before the Commission be reviewed in a manner acceptable to the staff of the Commission. Wright and Herman submitted Offers of Settlement in which they consented to the Order without admitting or denying the facts, findings or conclusions set forth therein.

The Opinion and Order is based upon permanent injunctions entered, in an action brought by the Commission, against Wright and Herman to which they consented without admitting or denying the allegations the Commission's complaint. The complaint alleged, among other things, that Wright and Herman violated the securities laws in connection with the preparation of materially false and misleading financial statements for The Midwestern Companies, Inc. (Rel. 34-23168; AAER-97)

PROCEEDINGS INSTITUTED AGAINST THOMAS W. TIERNEY

The Commission issued an Order Instituting Proceedings and Opinion and Order Imposing Remedial Sanctions in administrative proceedings under Rule 2(e) of the Commission's Rules of Practice against Thomas W. Tierney, an attorney who practices in Kansas City, Missouri. The Opinion and Order permanently denies Tierney the privilege of appearing or practicing before the Commission. He is permitted to apply to resume such appearance or practice after three years. Tierney submitted an Offer of Settlement in which he consented to the Order without admitting or denying the facts, findings or conclusions set forth therein.

The Opinion and Order is based upon a permanent injunction entered, in an action brought by the Commission, against Tierney, among others, to which he consented without admitting or denying the allegations the Commission's complaint. (Rel. 34-23169)

CIVIL PROCEEDINGS

RONALD WALKER, OTHERS NAMED IN CIVIL ACTION

The Commission filed an action for injunctive relief on April 22 in the U.S. District Court for the Western District of Missouri against Ronald Walker, Carl Wright, Lewis Herman, Thomas Tierney, Ira Palmer, Tim Compton, and Carl Keller, Jr., formerly officers, directors or major shareholders of The Midwestern Companies, Inc. Wright, Herman, Tierney, Palmer, Compton and Keller consented to Final Judgments without admitting or denying the allegations in the Commission's complaint.

The complaint alleged that: (1) Walker, Wright, Herman and Tierney violated the antifraud and periodic reporting provisions of the Securities Exchange Act of 1934; (2) Walker and Tierney violated the registration provisions of the Securities Act of 1933; (3) Palmer and Compton had violated the registration provisions of the Securities Act and antifraud provisions of the Securities Act and Exchange Act; and (4) Keller violated the registration provisions of the Securities Act.

Tierney agreed to disgorge \$165,000 which the Commission alleged represented improper profits from Tierney's transactions in Midwestern stock while in possession of material, non-public information regarding Midwestern. (SEC v. Ronald R. Walker, et al, USDC WDMO, Civil Action No. 86-0523-CV-W-6). (LR-11071; AAER-96)

INVESTMENT COMPANY ACT RELEASES

KEMPER TAX-EXEMPT INCOME TRUST

An order has been issued exempting Kemper Tax-Exempt Income Trust, Kemper Sales Company (KSC), and other unit investment trusts underwritten by KSC from the provisions of Rule 22c-1 of the Investment Company Act. The exemption permits KSC to offer units of future series of the Trusts on the first business day of the initial offering period of each series at a price other than that next computed after receipt of a purchase order. (Rel. IC-15064 - April 22)

CNA GROWTH STOCK FUND, INC. AND CNA BOND FUND, INC.

An order has been issued declaring that CNA Growth Stock Fund, Inc. and CNA Bond Fund, Inc. have ceased to be investment companies. (Rel. IC-15065 - April 22)

HOLDING COMPANY ACT RELEASES

WEST TEXAS UTILITIES COMPANY

A notice has been issued giving interested persons until May 12 to request a hearing on a proposal by West Texas Utilities Company (WTU), subsidiary of Central and South West Corporation, to issue and sell up to \$60 million of its first mortgage bonds, Series O, in accordance with alternative competitive bidding procedures. The proceeds will be used, together with internally generated funds, if necessary, to repurchase for cash by Tender Offer up to \$50 million of its outstanding first mortgage bonds, Series M, and up to \$815,000 of its 16-1/8% debentures, Series 1982.

WTU presently intends to hold open the Tender Offer for up to ten days but, if market conditions require or particular security holders require, WTU requests authority to shorten or extend the Tender Offer period. In addition, WTU requests authority to purchase securities from individual security holders after the expiration of the Tender Offer on terms no more favorable to such security holders than the terms extended under the Tender Offer.
