RULES AND RELATED MATTERS

PROPOSED AMENDMENTS TO RULE 31a-2

The Commission is proposing for public comment amendments to Rule 31a-2 under the Investment Company Act of 1940. The proposed amendments would permit registered investment companies to preserve required records on magnetic tape, disk, or other computer storage medium subject to certain conditions. Comments should be submitted in triplicate on or before August 22, 1986, to Shirley E. Hollis, Acting Secretary, Securities and Exchange Commission, 450 Fifth Street, N.W., Washington, D.C. 20549. ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST FIRST AFFILIATED SECURITIES, INC.

The Commission instituted administrative proceedings against First Affiliated Securities, Inc. on June 18, 1986. Simultaneous with the institution of those proceedings, First Affiliated consented to the Commission's order without admitting or denying the facts or the findings. These proceedings arose from the fraudulent conduct of a former branch manager of First Affiliated and the failure by the firm to supervise adequately that employee. The order censures First Affiliated and requires it to comply with its representations and undertakings including the firm's representation that it has retained an independent outside consultant who has conducted a review of, and made recommendations as to, First Affiliated's supervisory and compliance policies and procedures. These recommendations were implemented in their entirety by the firm and included new compliance procedures for review of the firm's market making activity in the over-the-counter market. The firm has further represented that it has retained the consultant to render advisory services to the firm for a minimum of 20 hours per month. First Affiliated also consented to an undertaking that it would implement and maintain a periodic, computer-generated analysis of the firm's securities trading. (Rel. 34-23335)

CIVIL PROCEEDINGS

INJUNCTION SOUGHT AGAINST CAPT. CRAB, INC. AND OTHERS

The Commission announced today the filing of a complaint for injunctive and other equitable relief in the U.S. District Court for the Southern District of New York against Capt. Crab, Inc.; Edward R. Scharps; Rooney, Pace Inc.; Randolph K. Pace; Joseph Lugo; Lewis Leeds; Inter-Financial Consulting Corp. (IFCC); and Martin Rothman. The complaint alleges that in 1982 and 1983 Capt. Crab, Inc., Scharps, Rooney Pace, Pace, Lugo, Leeds, IFCC, and Rothman violated certain of the stock registration, anti-fraud, and anti-manipulation provisions of the Federal securities laws in connection with the offer, purchase, and sale of the securities of Capt. Crab's Take-Away, Inc. and Crab House, Inc., the predecessors of Capt. Crab, Inc., all of Miami, Florida. Simultaneous with the filing of the complaint and without admitting or denying the allegations, Capt. Crab, Inc. consented to the entry of a final judgment of permanent injunction restraining and enjoining it from further violations of Sections 5 and 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5. (SEC v. Capt. Crab, Inc., et al, SDNY, CA No. 86-4785 (PNL)) (LR-11131)

SEQUOYAH-X LIMITED PARTNERSHIP

An order has been issued exempting a real estate limited partnership from all provisions of the Investment Company Act. (Rel. IC-15146 - June 11)

COMMERCIAL LIFE INSURANCE COMPANY

An order has been issued on an application filed by Commercial Life Insurance Company, Commercial Separate Account A, and Continental Equities Corporation of America under Section 6(c) of the Investment Company Act of 1940 exempting applicants from the provisions of Sections 2(a)(32), 22(c), 26(a)(2), 27(c)(1), 27(c)(2), and 27(d) of the act and from Rules 6e-3(T)(b)(12), 6e-3(T)(b)(13), 6e-3(T)(c)(1), and 22c-1 to the extent requested. This order permits general account funding and permits the deduction of a contingent deferred administrative and state tax charge in connection with the issue of flexible premium variable life insurance contracts.
